I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Radha Raman Kumar, S/O- Rameshwar Kumar of village – Maunia, P.O. – Kalimati P.S- Bagmundi Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 09/01/2023 at about 11:20 a.m. I Sri Swapan Kumar Das, AE & Station Manager, Bagmundih CCC along with 1. Abdul Hasib, ACM 2. Subhasis Mahato, Sr. O.E. entered the premises of Sri Radha Raman Kumar, S/O Rameshwar Kumar of village - Maunia, P.O. - Kalimati P.S- Bagmundi, Dist- Purulia and found Sri Radha Raman Kumar was enjoying electricity unauthorizably drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.15 KVA. As Sri Radha Raman Kumar S/O- Rameshwar Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Abdul Hasib, ACM 2. Subhasis Mahato, Sr. O.E.
