**Sub:** Complain against Bidhan Chandra Mondal (38 Yrs) S/O- Lt. Manoranjan Mondal of vill+P.O-Ankro, P.S- Boro, Dist – Purulia to start a Cog case U/S 46A(C) B.E. Act 1909.

## Respected Sir,

In producing here with arrested accused person namely Bidhan Chandra Mondal (38 Yrs) S/O- Lt. Manoranjan Mondal of vill+P.O-Ankro, P.S- Boro , Dist - Purulia along with seized Foreign liquor & Country Liquor(details of seized articles are mentioned in attached seizure list), I beg to submit that today i.e. on 02/01/23 at about 14:45 hrs. I received a credible source information that one person Bidhan Chandra Mondal (38 Yrs) S/O- Lt. Manoranjan Mondal of vill+P.O-Ankro, P.S-Boro, Dist - Purulia is carrying Foreign liquor & Country Liquor in bulk quantity on his motorcycle bearing Regd No- JH05CP0515 for selling without any valid license coming from Bandwan Rimi bypass side. Accordingly, I along with force (SI Suvajit Nandi, C/2610 Gopal Patra and C/2451 Nikhil Nayek all are of Bandwan P.S. Dist-Purulia) vide Bandwan P.S. C.C. No. 10/23 Dtd: 02/01/23 proceeded to that direction to work out the said source information and I detained one suspect with his motorcycle at Rimi bypass more, P.S-Bandwan Dist - Purulia who was carrying five carton boxes tied with his motor cycle bearing Regn no- JH05CP0515. We stopped him and during search with the help of accompany force, we found that the said person is carrying Foreign liquor & Country Liquor of different brand in those five carton box. Being asked, he disclosed that all liquor has been stocked and carried for the purpose of selling. On demand, he failed to produce any valid documents/ License in respect of stocking and selling of Foreign liquor & Country Liquor. Accordingly, I seized all the Foreign liquor & Country Liquor (details in attached seizure list) in between 15:05 hrs to 15:35 hrs after preparing proper seizure list duly signed by the witnesses. Approx cost of the Foreign liquor & Country Liquor is Rs 28,030/-. Then, I arrested him at 15:45 hrs maintaining all legal procedures regarding arrest as laid down by Hon'ble Supreme Court after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909 and supply one copy to him.

Under the above circumstances and fact, I therefore pray that a Cog. case may kindly be started **U/S 46A(C) B.E. Act 1909** against the arrested accused person namely Bidhan Chandra Mondal (38 Yrs) S/O- Lt. Manoranjan Mondal of vill+P.O-Ankro, P.S- Boro, Dist – Purulia and arrange for its investigation.
