Sub: Complaint against Chandramohan Mahato (55 Yrs) S/o- Lt. Durga Mahato of Vill- Rajdih, PS- Barabazar, Dist- Purulia to start a specific case under proper section of Law.

Sir,

In producing here with arrested accused person namely Chandramohan Mahato (55 Yrs) S/o- Lt. Durga Mahato of Vill- Rajdih, PS- Barabazar, Dist- Purulia and seized (i) One plastic jarakin containing approx 09 (Nine) liters ID liquors on which 500 ml taken as sample (ii) 03 (Three) plastic glass.

I, ASI Manas Kumar Pan of Barabazar PS do here by lodge this complaint against one Chandramohan Mahato (55 Yrs) S/o- Lt. Durga Mahato of Vill- Rajdih, PS- Barabazar, Dist-Purulia. I beg to state that today i.e. 13.01.2023 myself along with C/- 1182 Santosh Kr. Mahato & C/- 1474 Tushar Kanti Mandal were left for special mobile duty vides Barabazar PS GDE No- 759 Dtd. 13.01.2023. During mobile duty at about 17.25 hrs I received information that one person was selling I.D liquor in his house at Rajdih village under Barabazar PS. I was there to verify the credibility of that information and immediately informed the I.C Barabazar PS. As per direction of I.C Barabazar PS myself along with forces had been to the said place to work out the information. At about 17.55 hrs myself along with force held a raid at Rajdih village and found that one person was keeping and selling ID Liquor (Cholai) in his house. Seeing the Police party buyers fled away, but we apprehended the house owner who was selling the ID Liquor (Cholai). On search I found (i) One plastic jarakin containing approx 09 (Nine) liters ID liquors (ii) 03 (Three) plastic glass. On demand, he failed to produce any valid documents / License in respect of keeping & selling I.D liquors (Cholai). On being asked he confessed his guilt and stated that he was selling the I.D liquors (Cholai) in his house to the local people with intent to make his own profit. He disclosed his identity as Chandramohan Mahato (55 Yrs) S/o- Lt. Durga Mahato of Vill- Rajdih, PS- Barabazar, Dist- Purulia. He also admitted that he has no license or any authorization for keeping or selling of I.D liquors (Cholai). Accordingly, I seized the above noted ID Liquors and others articles after preparing proper seizure list and put label on the seized articles in presence of witnesses and on which 500 ml of I.D liquor (Cholai) taken as sample which were also duly labeled by me and also took signature of the accompanying witness on seizure list and label as well as accused person also. The seizure and label was done in between 18.05 hrs and 18.35 hrs.

Thereafter, I arrested the involved accused person namely Chandramohan Mahato (55 Yrs) S/o- Lt. Durga Mahato of Vill- Rajdih, PS- Barabazar, Dist- Purulia after preparing Arrest Memo & after observing all other formalities regarding arrest as per Cr.PC and NHRC guideline. Accordingly, informed regarding the ground of arrest and also informed his family members. The arrest was made on 13.01.2023 at 18.55 hrs.

Under the above fact & circumstances I therefore, pray before you that a specific case may kindly be registered against the involved arrested accused person namely Chandramohan Mahato (55 Yrs) S/o- Lt. Durga Mahato of Vill- Rajdih, PS- Barabazar, Dist- Purulia under proper section of Law.
