In producing herewith one arrested accused person namely Sk. Anisur Rahaman (34 Yrs) S/O Sk. Alam of Vill – Khatra Mushlim Para, PS - Khatra, Dist- Bankura along with one seized vehicle (Dumper) bearing registration No. WB 67B/7456 loaded with approx 500 cft. stone chips.

I bag to stated that today i.e. on 10.01.2023 I along with C/1250 Jitendranath Dubey and C/253 Arabinda Mallick vide Boro PS C.C. No. 95/2023 and GDE No. 315 dtd 10.01.2023 were engaged performing Day mobile duty at 11.35 hrs received a credible source information that the above noted vehicle (Dumper) bearing registration No. WB 67B/7456 was transporting stone chips illegally and coming from Bari village side. Myself along with force had been towards Bari village on Bari Dangardih Picth road under Boro P.S, Dist-Purulia to work out the information. When we reached near Jagda village more at 12.05 hrs and found that said vehicle were coming from Bari Village Side. Seeing the police party, driver of the said vehicle (Dumper) tried to flee away keeping the vehicle on the road. We chased him and after a hot chase could be able to intercept drivers of the said vehicle. Then we searched the vehicle and found that the registration no of vehicle No. WB 67B/7456 and the vehicle are loded with approx 500 cft stone chips. On asked the driver disclosed his identity as Sk. Anisur Rahaman (34 Yrs) S/O Sk. Alam of Vill – Khatra Mushlim Para, PS - Khatra, Dist- Bankura. I asked to produce valid documents in respect of the said vehicle as well as stone chips loaded in it. But he failed to produce any valid documents in respect the vehicle as well as stone chips loaded in it. On asked the above noted driver confessed his guilt and stated that he transporting stone chips in such way since long.

Hence there is every reason to believe that the driver namely Sk. Anisur Rahaman (34 Yrs) S/O Sk. Alam of Vill – Khatra Mushlim Para, PS - Khatra, Dist- Bankura along with one seized vehicle (Dumper) bearing registration No. WB 67B/7456 loaded with approx 500 cift stone chips in vehicle and owner of the above mentioned vehicle with ill motive are transporting stone chips illegally without any valid documents in support of carrying stone chips in a clandestine manner since few days and they are habitual in transportation of stone chips illegally by clandestine manner for their wrongful gain. Finding no other alternative I seized the said seized vehicle (Dumper) bearing registration No. WB 67B/7456 loaded with approx 500 cft stone chips under proper seizure list and arrested the driver namely Sk. Anisur Rahaman (34 Yrs) S/O Sk. Alam of Vill – Khatra Mushlim Para, PS - Khatra, Dist- Bankura after observing all legal formalities. After that I brought 01 arrested accused driver namely Sk. Anisur Rahaman (34 Yrs) S/O Sk. Alam of Vill – Khatra, Dist- Bankura and the seized vehicle (Dumper) bearing registration No. WB 67B/7456 loaded with approx 500 cft stone chips at PS.

So, there is also reason to believe that the driver and registered owner of the vehicle (Dumper) have transported the said stone chips by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose off the same at anywhere in a clandestine manner knowing it to be stolen as per their regular practice.

I therefore pray that a specific case may kindly be started against arrested accused driver namely Sk. Anisur Rahaman (34 Yrs) S/O Sk. Alam of Vill – Khatra Mushlim Para, PS - Khatra, Dist- Bankura, of vehicle no WB 67B/7456 and owner of the vehicle as per law and arrange for its investigation.
