To, The OC Hura PS Dist.- Purulia.

Sir,

I SI Bablu Ghosh of Hura PS do hereby lodge the complaint against unknown 200/250 male & female.

I beg to state that today (11.01.23) while I along with officers, force & Lady constable were performing L/O duty in c/w demonstration programme of Adibasi Sengel Abhijan at Lapur morh which refers to Hura PS GDE No- 438, Dtd- 11.01.23, C.C No. 110/22 dtd-11.01.2023 and at about 12.35 hrs. 200/250 male & female of unknown persons (Leaders and members of Adibasi Sengel Abhijan) suddenly blocked Bankura-Purulia NH60A road at Lalpur morh without any prior information and permission. As a result a large number of vehicle were obstructed at both side of Lalpur morh. I asked them to disperse with loud and clear voice but they did not pay any heed to my words. I also tried to convince them but they did not pay any heed to my request. On being asked the above accused persons could not be able to give any satisfactory answer for that movement on Purulia-Bankura NH60A road and blocked the public place. We started waiting and trying to convince them to clear the road for the interest of common people but our entire endeavor went air. They were willfully doing this blockade with an intention to injurious affect to the national highway causing esteem inconvenience to common people violating our order without having any order either from any concerned authority. By this way they blocked the road about 02 (two) hours and they withdraw it at around 14.45 hrs. During enquiry I could not be identified the above noted male female persons so far.

Therefore I am requesting you to start a specific case against the unknown 200/250 male and female under proper section of law and arrange for its investigation.
