Sir,

In producing herewith the arrested accused persons namely (i) Irfan Sekh (33) S/O Aku Sardar of Bagandih, Ward no-7, PS-Jhalda, Dist-Purulia and (ii) Azizul Sk (40) S/O Jamal Kazi of Bagandih, Ward no-7, PS-Jhalda, Dist-Purulia before you, along with seized articles like (i) Board money amounting to RS- 7800/- (ii) 42 pieces of Playing cards (iii) Approx 5 fit/4 fit white colour plastic sheet as per seizure list from a common gaming house i.e. the house of Irfan Sk (33) S/O Aku Sardar of Bagandih, Ward no-7, PS-Jhalda, Dist-Purulia which is equipped with the sufficient light of electricity.

I, ASI Dinabandhu Bauri along with (i) RM/1530 Bickey Magar and (ii) RM/1446 Nima Lama were performing the Day Mobile duty vide C.C No- 46/2023 dated- 05/01/2023 in consonance with the Jhalda PS GDE No-209 dated 05/01/2023. During my Day mobile duty, I received a tip of that one gambling with huge amount was going on at the house of Irfan Sekh (33) S/O Aku Sardar of Bagandih, Ward no-7 under Jhalda PS. Subsequently, I informed to you and as per your order, I along with force left for the house of Irfan Sekh at Bagandih, Ward no-7 under Jhalda PS to work out the information by government vehicle. At about 17:25 hrs, we reached yonder to the house of Irfan Sekh at Bagandih, Ward no-7 and leaving the vehicle, on foot very slowly and cautiously approached towards the house of Irfan Sekh where the gambling was reportedly going on and arrived at the house at about 17:35 hrs. From the outside of said house, we heard the talking of persons present there and within a few moment it was clear that the persons present there were continuing gaming with playing cards in exchange of money causing wrongful loss to one and wrongful gain to another. After that, I asked my associate staffs to cordon the place and within a moment the place was cordoned by Police party. We disclosed our identity and requested them to search myself and my other staff accordingly the persons searched ourselves and found nothing except wearing apparels and Mobile Phones. After that we asked their identity and the persons disclosed their names and addresses as noted above and some persons are fled away. It was found that a huge amount of currency note of different denomination were kept on gaming board i.e. one White plastic placed on the floor and the room of the common gaming house was equipped with sufficient light of electricity and the playing cards were also found. On demand the persons clearly confessed that all of them were doing gambling with playing cards in exchange of money for wrongful loss to one and wrongful gain to another. We searched for the public witnesses but none was available. Subsequently, I seized the following articles such as (i) Board money amounting to RS- 7800/- (ii) 42 pieces of proper seizure list duly signed by the above noted accused persons in presence of the available witnesses in between the 17:45 hrs - 18:35 hrs. and sealed and leveled in presence of witnesses and the accused persons. The copy of seizure list was supplied to the accused persons.

As the above noted accused persons committed offence punishable u/s- 3 & 4 of West Bengal Gambling and Prize Competition Act, 1957, so I arrested them at 18:40 hrs after informing them the ground of arrest and issued memo of Arrest in respect of each of the above persons.

From the statement of accused persons it was clear that they along with Muktar Sekh of Bagandih, Rajesh Kumar of Kumar Kuli, Jhalda and others were playing cards in the house of Irfan Sekh (33) S/O Aku Sardar of Bagandih, Ward no-7, PS-Jhalda, Dist-Purulia.

Therefore, I pray before you that one specific case may kindly be start under proper section of law against the accused persons namely (i) Irfan Sekh (33) S/O Aku Sardar of Bagandih, Ward no-7, PS-Jhalda, Dist-Purulia and (ii) Azizul Sk (40) S/O Jamal Kazi of Bagandih, Ward no-7, PS-Jhalda, Dist-Purulia, Muktar Sekh of Bagandih, Rajesh Kumar of Kumar Kuli, Jhalda and others and arrange its investigation.
