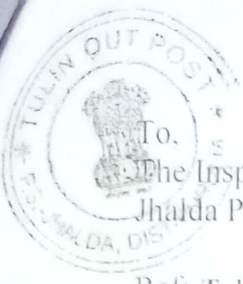

Sir,

In producing here with one Lalbabu Paramanik (30 yrs) S/O-Satrughan Paramanik of vill-Mosina, PS-Jhalda, Dist-Purulia after arrest with one seized Tractor having Registration Number WB55A/6313 & chasis No-MBNABAEAKHRD00857 & Engine No-RHD2EAN3729 attached with Trolley loaded with approx 100 CFT of sand.

The fact of the case in brief is that today 08/01/2023 I SI Montaz Sheikh , C/3008 Kartik Dule, C/186 Ananda Das all of Tulin OP under Jhalda PS were performing anticrime Spl. mobile duty at Tulin OP area. At about 10:05 hrs I received a credible source information that one Tractor was lifting & carrying sand illegally and coming from Subarnarekha Ghat which is situated on Subarnarekha River at Jharkhand Purulia Border & coming towards Jhalda side. Subsequently, I informed you and as per your order, I placed Naka at Banglatar more to work out this tip off and started Naka Checking after proper placing guard rail on the road. Thereafter I saw the one tractor was proceeding towards Near Subarnarekha Bridge. Consequently, we intercepted the said Tractors at Naka checking point on 08/01/2023 at about 10:20 hrs. On seeing my signal driver of the said tractor immediately stopped the vehicle and we managed to apprehend the driver of the above noted Tractor. On asking he gave his name and address as Lalbabu Paramanik (30 yrs) S/O-Satrughan Paramanik of vill-Mosina, PS-Jhalda, Dist-Purulia. On demand he failed to produce any paper in respect of loaded sand as well as of the tractor and also made incoherent statement in respect of loaded sand. So it is reasonable to belief that the above noted Driver and Owner of the said Tractor were procured the said sand either by theft or by illegal means from Subarnarekha River side and runs this illegal clandestine business of sand without any royalty challan. Finding no any other alternative way I seized the said Tractor having Registration Number WB55A/6313 & chasis No-MBNABAEAKHRD00857 & Engine No-RHD2EAN3729 attached with Trolley loaded with approx 100 CFT of sand under proper seizure list.

On return to Jhalda P.S., I produced the arrested driver namely Lalbabu Paramanik (30 yrs) S/O-Satrughan Paramanik of vill-Mosina, PS-Jhalda, Dist-Purulia along with seized Tractor having Registration Number WB55A/6313 & Chasis No-MBNABAEAKHRD00857 & Engine No-RHD2EAN3729 attached with Trolley loaded with approx 100 CFT of sand at Jhalda PS compound and I do here by submitting written complaint before you to start a cog case against the above noted driver of the above noted tractor and against it's registered owner under proper section of law.
