Sub- FIR/taking necessary action against the marrying, solemnizing and promoting the child marriage of the daughter of Chuku @ Hemanta Kuiry of vill- Kudlung , PO- Torang, PS- Jhalda dist Purulia.

Sir,

I Jyotirmay Chatterjee , Data Manager, Kanyashree Prakalpa , Jhalda-I Development Block , Purulia would like to inform you that on 18.01.23 BDO Jhalda-I received a information of Child Marriage of the daughter of Chuku @ Hemanta Kuiry of vill- Kudlung , PO- Torang, PS- Jhalda Dist Purulia had been solemnizing in his house. Subsequently, as per his endorsement, I along with the police team led by SI Ashok Kumar Sen left for the Kudlung village to work out as well as to stop the child marriage of the daughter of Chuku @ Hemanta Kuiry of vill- Kudlung , PO- Torang, PS- Jhalda Dist Purulia. On arriving at the said village on 19.01.23 at 00:05 hrs it was found that a marriage party was about to end in the house of said person. On endemic and tangible enquiry it was found that the marriage of a minor girl aged about 16/17 yrs daughter of Chuku @ Hemanta Kuiry Kudlung village had already been solemnized with one Bibhuti Kuiry aged 21 yrs S/O Mahadeb Kuiry of Vill- Dibitikar , PO- Illu, PS- Jhalda , Dist- Purulia on 18.01.23 at about 12 O'clock . On meticulous and elastic enquiry it was found that the marriage had been solemnized in a Dalbera Rammandir under Silli PS under Jharkhand State to circumvent the clutch of administration. It is pertinent to say that the parents of the girl child as well as the parents of the groom i.e. Bibhuti Kuiry aged 21 yrs S/O Mahadeb Kuiry of Vill- Dibitikar , PO- Illu, PS- Jhalda , Dist- Purulia consented /permitted the said marriage in the house of of Chuku @ Hemanta Kuiry of vill- Kudlung , PO- Torang, PS- Jhalda Dist Purulia in the morning of the date of marriage. It is also found in the enquiry that the girl child went to the house of Bibhuti

Kuiry aged 21 yrs S/O Mahadeb Kuiry of Vill- Dibitikar , PO- Illu, PS- Jhalda , Dist- Purulia as his bride. She was not available in her paternal house. Consequently, I along with the police team arrived at the Dibitikar village at about 02.35 hrs on 19.01.23 and found that another marriage party had already been ended in the house of Bibhuti Kuiry aged 21 yrs S/O Mahadeb Kuiry of Vill- Dibitikar , PO- Illu, PS- Jhalda , Dist- Purulia but both the girl child i.e. bride and the groom were not available in his house. Consequently, I was unable to recover the girl child at that time being. The family members of the groom were uttering incoherent statement to circumvent the administration and they asked me that they would produce both the girl child and the groom in the morning at police station for further procedure. During the endemic and tangible enquiry it was found that approx 150 invitees of Dibirtikar village and Kudlung village were invited in the marriage party to promote the child marriage knowing the fact that the girl had been reading in the class IX in the Pusti Anchal High School.

However, I am putting forth the above factual information before you for initiating a FIR and taking necessary action against the parents of the girl child as well as the ~~bride~~ groom namely Bibhuti Kuiry aged 21 yrs S/O Mahadeb Kuiry of Vill- Dibitikar , PO- Illu, PS- Jhalda , Dist- Purulia who marrying the girl child and his parents as well as all the invitees who have solemnized and promoted the child marriage under the purview of the Prohibition of Child Marriage Act, 2006 (amended up to date).
