Sir,

In producing here with one arrested accused person namely Sanat Dutta (63 Years) S/O-Lt. Radha Kishore Dutta of Poddar Para, Ward No-9, PS-Jhalda, Dist-Purulia and brought under seizure of the following articles i.e. (i) 24 (Twenty four) Pcs sealed bottles of Dextromethorphan Hydrobromide & Chlorpheniramine Maleate Syrup ESkuf-Dx Cough Syrup @ Rs. 124/- per bottle, having 100 ml in each bottle from the possession of the accused person mentioned above. I SI- Asoke Kr. Sen of Jhalda PS do here by lodged a written complaint against Sanat Dutta (63 Years) S/O-Lt. Radha Kishore Dutta of Poddar Para, Ward No-9, PS-Jhalda, Dist-Purulia to the effect that today (20/01/2023) while performing day mobile duty (This refers to Jhalda P.S. GDE No- 959 Dt- 20/01/2023, vide C.C. No- 212 Dt- 20/01/2023) near at Birsamore, I received an information from my source at about 13:05 hrs that one person, the owner of the Annapurna Medical Hall has stored huge quantity of Cough Syrup for selling clandestinely from his shop styled as "Annapurna Medical Hall" to the youth customers of Jhalda town area. After having received this information I immediately informed to you. Subsequently, as per your gracious direction, I SI- Asoke Kr. Sen along with (i) RM/1515 Jiban Chhetri (ii) RM/1530 Bicky Magar both EFR 3<sup>rd</sup> Bn, Salua camp at Jhalda PS left Birsamore immediately to work out the information. We, all reached with Govt. Vehicle near Annapurna Medical Hall near Jhalda Municipality at 13:15 Hrs and held raid at above noted medical shop and found (i) 24 (Twenty four) Pcs sealed bottles of Dextromethorphan Hydrobromide & Chlorpheniramine Maleate Syrup ESkuf-Dx Cough Syrup @ Rs. 124/- per bottle, having 100 ml in each bottle in his shop. On interrogation he disclosed his identity as the owner of the shop as mentioned above. On demand he failed to produce any valid documents/license in respect of keeping huge quantity of illegal Drugs. So I seized the same under proper seizure list duly signed by the police witnesses as there was no other local witnesses available there right that moment and on request no one come forward to be the witness in this case and as well as signed by the apprehended person and also prepared label with seal and from which 01 (one) bottle of cough syrup was kept as sample. He also disclosed that he was running Cough Syrup (illegal drugs) business since long from his "Annapurna Medical Hall" illegally and today he was with huge quantity of Cough syrup in his shop and keep there for the purpose of selling illegal drugs to the local youth customers. Subsequently, I arrested the said accused person for violating the Sec-27 of Drugs & Cosmetics Act-1940 after maintaining all the formalities regarding arrest and all the guide line of Hon'ble Supreme Court and NHRC.

I, therefore pray before you to start a case against accused person namely Sanat Dutta (63 Years) S/O-Lt. Radha Kishore Dutta of Poddar Para, Ward No-9, PS-Jhalda, Dist-Purulia U/S 27 of Drugs & Cosmetics Act-1940 and arrange for its investigation.


