Sir,

In producing here with arrested accused persons namely 1) Md. Shakeel Ahamed (46) S/O Lt. Jahir Khan of Mira Tola, Jama Masjid, PS-Kannauj, Dist- Kannauj (UP), 2) Sk. Mehaboob @ Alua (37) S/O Sk Belal of Vill- Kantadih, PS-Jhalda, Dist-Purulia 3) Kishor Bhagat (57) S/O Lt. Durga Bhagat of Vill- Bulbul, PO+PS- Pesrar, Dist- Lohardaga, JKD 4) Shibnandan Sharma (45) S/O Lt. Bihari Mistri of Vill- Melatri Camp, Paharpur, PO-Erodrum, PS-Magad Metkar, Dist- Goya, Bihar and seized articles 1) One Country made improvised fire arms approx. 10 inches in full length of which barrel approx. 6 inches and butt approx. 4 inches loaded with one 08 mm. Live Ammunition 2) One Iron Saw with wooden Butt length approx. 20 inches. and wooden Butt length approx. 6.5 inches 3) One Iron Batali with wooden Butt, Iron part length approx 07 inches. and wooden Butt length approx 14 inches 4) one iron rod length approx 4 ft 5) one lylon rope in blue colour length approx 25 ft lodged complain against them and 11/12 others to the effect that on 23/01/2023 at about 22.35 Hrs during my evening mobile duty received a credible tip that a gang of dacoits being armed with deadly weapons assembled under a Palash tree situated at Pathar Bandh near Railway level crossing on Jhalda Gola Road and they were preparing themselves for committing dacoity at Jhalda Town area/nearby resorts. Subsequently I, informed to you as well as to the duty officer and as per your direction I asked the duty officer to note the information down in the GDE Vide Jhalda PS GDE No 1126 Dated 23/01/2023 and to send additional officer and force to assist me. On getting the tip off as per kind order myself accompanied with force who were detailed for the evening Mobile Duty with me namely (i) C/-331 Mansaram Kumar, (ii) JC/1424 Samim Ansary & (iii) HG/1772 Fatik Ch. Kumar all of Jhalda PS vide CC No. 2301 dated 23/01/2023 vide Jhalda PS GDE NO 1109 Dated 23/01/2023 immediately proceeded to the anticipated place of assembly to work out the information and reached near Railway level Crossing at 23:05 Hrs and ASI Khirod Baran Sardar accompany with force namely (i) C/240 Manoranjan Bagti (ii) NVF/1036 Pramatha Kuiry all of Jhalda PS joined me for assistance. After that, leaving the Police Vehicle No- WB 56C/5712 & WB 56M/7939 and started to proceed for the anticipated place on foot. At 23:15 Hrs reached at anticipated place laid on ambush and we noticed in a glimpse of light that 15/16 persons assembled under a Palash tree situated at Pathar Bandh 60 mtr away from the Jhalda-Gola main Road and those persons are whispering from which it was clear that they are preparing themselves to commit dacoity as it could be audible from the parlance of the assembled criminals. We cordoned them very cautiously. Then after disclosing our identity, I commanded them to surrender but they did not pay any heed and tried to flee away. We succeeded to nab in rounding up 04 (Four) of them while the rest 11/12 had managed to escape despite of a hot chase after them. They disclosed their identity as mentioned above. We told them we want to search them if necessary they can search the police party, but they told they are not willing to search us, then after observing all formalities I searched the above noted apprehended persons and recovered the following articles from the exclusive possession of the respective accused persons 1) One Country made improvised fire arms approx. 10 inches in full length of which barrel approx. 6 inches and butt approx. 4 inches loaded with one 08 mm. Live Ammunition from the possession of Md. Shakeel Ahamed . Subsequently, I safely unloaded the ammunition covering all safety & security measures 2) One Iron Saw with wooden Butt length approx. 20 inches. and wooden Butt length approx. 6.5 inches from the possession of Shibnandan Sharma 3) One Iron Batali with wooden Butt, Iron part


length approx 07 inches. and wooden Butt length approx 14 inches from the possession of Kishor Bhagat 4) one iron rod length approx 4 ft from the possession of Mehaboob @ Alua 5) one lylon rope in blue colour length approx 25 feet from the possession of Mehaboob @ Alua. Then in between 00:05 hrs to 00:35 hrs on 24/01/2023 from the place of assembly of the accused persons and from the possession of the above noted apprehended persons, after observing all formalities, I seized 1) One Country made improvised fire arms approx. 10 inches in full length of which barrel approx. 6 inches and butt approx. 4 inches loaded with one 08 mm. Live Ammunition 2) One Iron Saw with wooden Butt length approx. 20 inches. and wooden Butt length approx. 6.5 inches 3) One Iron Batali with wooden Butt, Iron part length approx 07 inches. and wooden Butt length approx 14 inches 4) one iron rod length approx 4 ft 5) one lylon rope in blue colour length approx 25 ft from the place of assembly under proper seizure list as well as the label duly signed by apprehended persons and witnesses as Alamat property in c/w above case. On interrogation they confessed their guilt and they stated that they have assembled there with 11/12 others namely Bhalka of Kantadih, Kamal of Kantadih, Sk Imroj of Kantadih, Jamir of Hussendih, Butla of Kantadih and others for committing a dacoity in Sikra Mountain & Hill Resort. I am to note here that I have to conduct search & seizure in presence of public witness but none was available as because as it was dead hour of night and it was a lonely place, so I could not able to accompany with public witness. Under such circumstances it is reasonably believed that the above noted apprehended persons were assembled there for committing Resort dacoity. So, after observing all formalities I arrested those persons after preparing memo of arrest and ground of arrest duly communicated to them.

Therefore, I pray that a specific case may kindly be registered against the arrested accused persons namely 1) Md. Shakeel Ahamed (46) S/O Lt. Jahir Khan of Mira Tola, Jama Masjid, PS-Kannauj, Dist- Kannauj (UP), 2) Sk. Mehaboob @ Alua (37) S/O Sk Belal of Vill- Kantadih, PS-Jhalda, Dist-Purulia 3) Kishor Bhagat (57) S/O Lt. Durga Bhagat of Vill- Bulbul, PO+PS- Pesarar, Dist- Lohardaga, JKD 4) Shibnandan Sharma (45) S/O Lt. Bihari Mistri of Vill- Melatri Camp, Paharpur, PO-Erodrum, PS-Magad Metkar, Dist- Goya, Bihar along with 05 others namely Bhalka of Kantadih, Kamal of Kantadih, Sk Imroj of Kantadih, Jamir of Hussendih and Butla of Kantadih and others under proper section of law.
