Sikha Das, W/O- Narayan Chandra Das) and brother-in-law (Sandip Biswas), suddenly with out any provocation they shouted on me to blame that I have so many extramarital affair, but it is completely baseless and false, and beaten up on my head and other body parts by their hand and sandals randomly, strangulate my neck, also kicked off my scrotum to rupture it (Copy of Medical finding and advice attached herewith). My land lord and few local people came and ask for calm down them but they didn't. I am feeling both fear and shame. My social reputation destroyed.
