In producing herewith seized 01 (one) Red Colour Mahendra Tractor without registration number bearing Chassis No-MBNABAEAKJRM01965 & Engine No-RJM2EAN1390 loaded with sand (100 CFT approx) under proper seizure list, I beg to submit that today (07/01/2023) I, ASI Swapan Mandal along with force (1) C/-842 Anshuman Tewari (2) C/-1356 Rajib Kundu (3) NVF/-803 Ankur Ch Mahato all of Joypur P.S were performing Day Mobile duty vide Joypur PS CC No-73/23 Date-07/01/2023. During my mobile duty at about 14:15 hrs received a credible source information that one tractor loaded with sand is coming from Chasmore side under Joypur PS, I along with force reached at Gunja more under Joypur PS and found that one seized 01 (one) Red Colour Mahendra Tractor without registration number bearing Chassis No-MBNABAEAKJRM01965 & Engine No-RJM2EAN1390 loaded with sand (100 CFT approx). On seeing the Police party at Gunja more under Joypur PS, the driver of the said tractor fled away leaving the tractor standing beside the road. We rushed to the tractor and searched the said tractor and found that the tractor loaded with sand and also searched surrounding the P.O but I did not trace out the driver & owner of the said tractor. Hence I seized the tractor without registration number bearing Chassis No-MBNABAEAKJRM01965 & Engine No-RJM2EAN1390 loaded with sand (100 CFT approx) under proper seizure list in between 14:25 hrs to 14:45 hrs in presence of available witnesses and I brought the said Tractor to Joypur P.S. As such there is every reason to believe that the driver and owner of the said tractor is dealing with sand illegally and transporting with ill motive without any valid document.

Hence, they are liable for offence punishable U/S-379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver and owner of the said Tractor may kindly be started and arrange for its investigation
