Lodging FIR against Paltu Mahato (32 yrs) S/o-Bhukhal Mahato of Vill-Srirampur tola Sub:

Sir,

In producing herewith one arrested accused person namely Paltu Mahato (32 yrs) S/o-Bhukhal Mahato of Vill-Srirampur tola Bhelaidih PS-Joypur, Dist-Purulia under arrest along with seized articles as per seizer list i.e. (1) 18 (Eighteen) liter Illicit liquor (locally known as Mohulla) kept in 20 liter white colour plastic jarican (2) One Black & Steel Colour Hero Honda Passion Plus Motor Cycle bearing Regd. No-JH05S-9586 under proper seizure with label.

I Swapan Mandal of Joypur PS hereby lodged a written complaint against the above noted arrested accused person to the effect that today (09/01/2023) at about 13:05 hrs when myself along with JC/-1551 Majnu Ansary & NVF/-817 Bhubaneswar Mahato were performed Special Mobile-I duty vide Joypur PS C.C. No-100/23 Date-09/01/2023 received credible source information that one person coming from Jahajpur village side to Srirampur village with one Motor Cycle loaded with approx 18 (Eighteen) liter Illicit liquor (locally known as Mohulla). I reached Tinmatha More infront of Rishi Arobinda Pathagar Srirampur under Joypur PS to work out the source information. We stop the Motor Cycle and found that approx 18 (Eighteen) liter Illicit liquor (locally known as Mohulla) kept in 20 liter white colour plastic jarican he carrying with his Motor Cycle bearing Regd. No-JH05S-9586. On seeing Police persons, he tried to fled away in the concealed place, after hot chase we able to apprehended him. On search found approx 18 (Eighteen) liter Illicit liquor (locally known as Mohulla) kept in 20 liter white colour plastic jarican hanging his MC. On being asked he disclosed his name and address as noted above. On interrogation he stated that he will selling illicit liquor (locally known as Mohulla) to the local people in Srirampur village area after collecting from other side but on demand he failed to produce any valid documents in respect of selling such illicit liquor (locally known as Mohulla). So it is reasonable to believe that he was selling the Id liquor illegally without any documents. So I seized the same under proper seizure list in between 13:25 hrs to 13:45 hrs & label duly signed by witnesses after taking 600 Ml of illicit liquor (locally known as Mohulla) as sample out of 18 (Eighteen) liter.

During further interrogation he confessed his guilt as such I arrested him today (09/01/2023) at 13:50 hrs as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely Paltu Mahato (32 yrs) S/o-Bhukhal Mahato of Vill-Srirampur tola Bhelaidih PS-Joypur, Dist-Purulia U/S-46A (c) of the Bengal Excise Act 1909.
