Sir,

In producing herewith one arrested accused person namely Sanjoy Mahato (23 yrs) S/o-Balaram Mahato of Vill- Kulara (Bandhdih) PS-Joypur, Dist-Purulia under arrest along with seized articles as per seizer list i.e. one white colour polithin Jariken containing approx 10 (ten) liter Illicit liquor (locally known as Mohulla).

I, SI Nagendra Nath Das of Joypur PS hereby lodged a written complaint against the above noted arrested accused person to the effect that on today 17/01/2023 at about 17:25 hrs when myself along with C/-2672 Pradip Patra C/-2620 Jayanta Kapat, were performed Special mobile-II duty vide Joypur PS C.C. No-191/2023 Date-17/01/2023, as per my source information I reached at Kulara tola Bandhdih village under Joypur PS and found that the above noted accused person selling illicit liquor (Mohula) in the dwelling house of Sanjoy Mahato (23 yrs) S/o-Balaram Mahato of Vill-Kulara tola Bandhdih PS-Joypur, Dist-Purulia. On seeing Police person, he conceal his presence at that place, but on searching we able to trace out him and also to found that 10 (ten) liter of Illicit Liquor (locally known as Mohulla) which was kept at his dwelling house. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling Illicit liquor to the local people in the area. On demand he failed to produce any valid documents in respect of selling such illicit liquor (Mohula). So it is reasonable to believe that he was selling the Id liquor (Mohula) illegally without any documents. So I seized the same under proper seizure list in between 18:15 hrs to 18:35 hrs & label duly signed by him and other available witness after taking 1 liter as sample in a separate bottle.

During further interrogation he confessed his guilt as such I arrested him today 17/01/2023 at 19:35 hrs as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely Sanjoy Mahato (23 yrs) S/o-Balaram Mahato of Vill- Kulara tola Bandhdih PS-Joypur, Dist-Purulia U/S-46A (c) of the Bengal Excise Act 1909.
