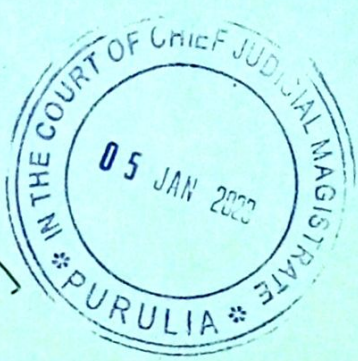

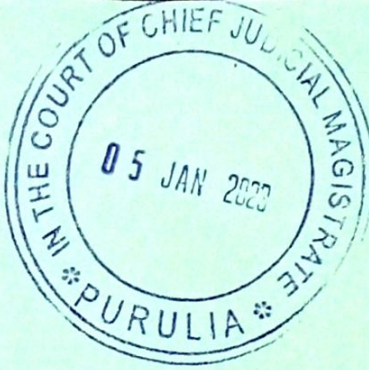

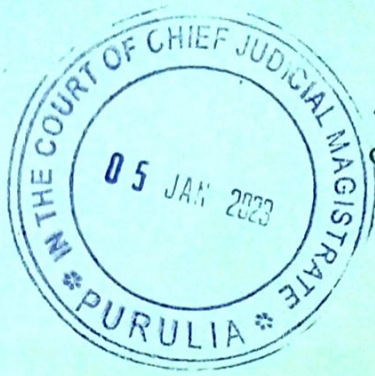

The humble petition on behalf of complainant;

Most respectfully begs to state as follows:-

1. That your complainant, injured and accused persons are all resident of Vill. Karkara under P. S. Joypur, Dist. Purulia within the jurisdiction of this Honourable court.
2. That son of your complainant is the employee under Chainpur BPCL and came at his house to take his meal and when he went to join his duty at about 1.30 p.m. on 22.12.2022 suddenly that time one Reyaz Ansary s/o Mairuddin Ansary of Vill. & P.O. Karkara, P. S. Joypur, Dist. Purulia attacked the son of your complainant namely Rajababu Sah from the behind and struck twice upon the head from the behind and sustaining blood injury son of your complainant felt down on the earth from his motor cycle and then accused took several attempt to killed him by assaulting through his lathi on the various part of the body, the injured receiving such assault lost his snace and at that time the accused snached his gold bangle from the head of injured and also snached Rs.14,700/- from the pocket of the injured the incident took place near at the hotel of Tahir Ansary on road and after assaulting and snaching the accused fled from the spot thinking the injured as dead.
3. That after for a while son of your complainant able to came at the house of your complainant and disclosed

everything thereafter he became senseless and by the help of villagers and witnesses complainant and witness took the injured before Joypur B.P.H.C. and doctor treated him and 3 stich were given at the head to prepared the injury and advised for C.T. scan and referred to better treatment and still his treatment is going on and due to brain injury injured used to lost his sence as and when stress come upon his head.

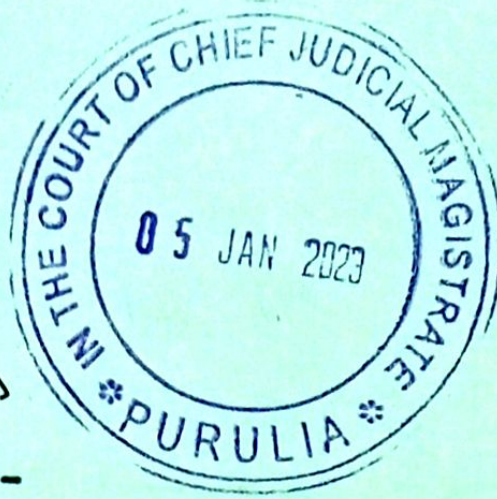
4. That entire incident were informed before the Pundag I.C. and they recovered the motor cycle and handed over to the complainant but did not take any legal action against the accused person.

5. That still the accused person threaten for dire consequences if the complainant lodge any case and accused is a Coal mafia and any time may take further attempt to killed my son.

6. That one written allegation has lodged before the Joypur P.S. but they did noting as the accused is a influential person then the matter has informed to the S.P. Purulia but of no good.

7. That there is every chance for recovery of the incriminatory articles as well as theft ~~in~~ item.
