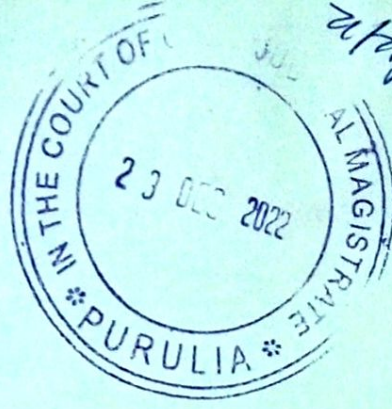
1. That the Complainant, Accused Person and the Witnesses are the permanent resident of Village Chowkibera, P.S.- Joypur, District - Purulia, having their residential houses therein.
2. That the Complainant belonged to Schedule Tribe Community & very poor person.

3. That the Accused Persons No.1 & 2, have got grudge against the family of the Complainant & the Accused Persons regularly used to abuse the Complainant with filthy languages and also by saying him as lower caste.
4. That when such state of things were going on, the Complainant went to Pond at village Chowkibera to attend nature's call on 17/08/2022 at 06.30 PM at that time the Accused Persons without any reason blocked his road & told that you will be murdered if you do not withdraw the pending Civil Suit. The Accused Persons also abused the Complainant with filthy language & insult him by saying Lower Caste (*Tora Nich Jati Toder sathe katha bala to dur chhaya maraleo pap hoy*) in presence of several persons standing by the side of road including other witnesses.
5. That the Complainant out of fear tried to flee away there from but the Accused Persons caught hold him and tried to take him forcibly towards the dark side and also caught hold his neck with intend to murder.
6. That the Complainant raised hue & cry and on hearing such noise several local villagers including the Witnesses reached there and on seeing them the Accused Persons fled away. At that time the Accused Persons also took away three Rs. 500/- currency notes from the pocket of the Complainant causing wrongful loss to him.
7. That after the incident the Complainant with the help of villagers reached his house and due to such incident and the threatening, the Complainant living with anxiety and he has fear of life.
8. That the Complainant thereafter on several occasions met the I/C Joypur P.S. informing all about the incident & requesting him to take steps against the Accused Persons but the police did not take any action in the matter up-till now.
9. That the Complainant also informed the matter to the S.P. Purulia on 29/08/2022 but up-till now no action has been taken by the police.
10. That thus the Complainant brought this case for the offences committed by the Accused persons for which they are liable to be prosecuted.

It is therefore prayed that your honour may graciously be pleased to treat this petition as a Complaint under Section-156(3) of the Cr. P.C. & send the petition to the I/C Joypur P.S. for investigation & further be pleased to pass necessary order.
