Subj:- Complaint to start a specific case in c/w Kotshila PS U/D Case No. 02/2023 dt. 11.01.2023.

Sir,

I, SI Ramu Gurung do hereby lodge complaint against unknown miscreant/miscreants to the effect that on 11.01.2023 at 15:05 hrs received a written information from one Ashok Kr Hansda S/O-Lt Chandramohan Hansda of Vill-Haratan, PS-Kotshila, Dist- Purulia to the effect that on 11.01.2023 at about 14:00 hrs one unknown decomposed married female dead body aged about 45 years found lying in a bush near Dimu Dam, Vill- Dimu , PS- Kotshila , Dist-Purulia. Over this started Kotshila PS U/D Case No. 02/2023 dt. 11.01.2023 and being endorsed by O/C Kotshila PS, I, SI Ramu Gurung took up its investigation. During my investigation, myself along with forces had been to Dimu village and visited SOC where the local villagers found the dead body of said unknown deceased. At first, I cordoned the SOC, and held inquest over the dead body of said deceased u/s 174 Cr PC and sent the same under proper escort of C/1543 Prabir Kr Mandal at Purulia Govt. Medical College & Hospital for holding P.M examination to ascertain actual cause of death. Accordingly, on 12.01.2023 Dr. Shobhan Roy, Assistant Professor, Department of Forensic Medicine & Toxicology, Deben Mahato Govt. Medical College & Hospital conducted P.M examination over the dead body of said deceased.

In course of investigation of Kotshila PS U/D case No. 02/23 Dt. 11.01.23, I sent all concern messages to west Bengal and Jharkhand state for identification of the said deceased and pasted photograph at many places for identification. I seized wearing apparels, blood stain, hair, nail cutting of said deceased after preparing proper seizure list duly signed by witnesses. On 17.01.23 prayed for wide publication of said deceased but the body of said deceased is not identified yet. Today (25.01.23) I received the P.M examination report with VISCERA of unknown female deceased bearing PM No. 35/2023 dt. 12.01.2023 in c/w Kotshila PS U/D Case No. 02/2023 Dt. 11.01.2023. On perusal, it could be learnt that autopsy surgeon Dr. Shobhan Roy who conducted the PM examination of said deceased, opined that "Death was due to the effects of antemortem injuries, homicidal in manner. However, further opinion, if any might be given after the receipt of Chemical Examiner's report".

Under the above circumstances, I pray before you that a specific may kindly be started against unknown miscreant/miscreants and arrange for its investigation.
