Sir,


I am writing this letter to draw your kind attention , that, I, Rinku Dey W/O Lt Tapas Kar, a resident of Kashipur deception by a person, named Akash Rajak Son of Ashish Rajak, Vill – Parsala, PS – Simlapal, Dist – Bankura, Phone No 8942950902. He make friendship with me and cheated me with an assurance to return back money. For some reason he took a huge amount of money from me with an assurance to give it back within 2-3 months. But he refused to repay me back the money. However, when, I asked him about the amount, he threatened me and began abusing me in a disgusting manner. He keeps threatening me, even late at night. He also told me that he will share some private information about me publicly. When I called over his home number for asking the amount which he was taken, in the mean time , he threatened me again to do something fatal, and I would have to suffer the consequences of that. After that I try to contact with your office regarding this matter. And my concern wasn't to harm anyone, but also to get my hard-earned money back. On 30/12/2022, he called my father over phone and said, that, he will commit suicide, if he has to pay the money. He also stated that, for his suicide, I will be the responsible person. In this regard, I'm writing this letter for his misdeeds and for having my money back. This document may be treated as an FIR. I'm a helpless widow, striving to feed my two kids with dignity and honor. I demand justice from the system, regarding this matter. Because this is a question of our safety, I suggest that you investigate the situation and take appropriate action as soon as possible. I eagerly anticipate your kind aid in this matter. The proofs of money receipts are attached herewith. The total amount of money given to him through UPI was Rs. 69373/-. Amount given in cash was Rs. 150000/-. Total amount cheated by said Akash Rajak is Rs- 219373/-(Rs Two Lakh nineteen thousand three hundred and seventy three only)/-.
