The complainant like previous years this year also transplanted paddy crops over the aforesaid agricultural lands, hence thereby, the accused persons nos. 1 & 2 became very much covetous. The accused persons nos. 1 & 2 since the last part of the month of November were trying to reap the paddy crops by committing theft belonging to the complainant.

- 4. That on 01/12/2022 at about 08 a.m. while the complainant usually went to the aforesaid agricultural lands situated at Mouza-Manjhupra to look after the development of paddies for rice production transplanted by them, found that the accused persons along with their associates have trespassed into the lands in the possession of the complainant and committed theft of paddy crops for an offence Under Section 379 IPC. In respect of the lands from which the accused are alleged to have committed theft of paddy crops. When the complainant raised objection and shouted loud at them, then the accused persons abused the complainant with all possible filthy and derogatory languages and threatened him with dire consequences and also touched several portion of his body and tried to push him aside in respect of the lands from which the accused are alleged to have committed theft of paddy crops.
- 5. That in the suddenness of the incident the complainant became fully perplexed as well as distracted and shocked and subsequently felt uneasy and sick being an aged person and a senior citizen. Thereafter, while the complainant returned to his house the complainant described in details/entire illegal activities of the accused persons to his other family members and even they were also amazed and confounded. They decided to go to Kashipur Police Station to lodge FIR against the accused persons.
- 6. That regarding the above referred facts, the complainant visited the Officer- in -Charge, Kashipur Police Station with intent to lodge an F.I.R against the said accused persons, namely AdityaBauri and MadhusudanBauri, but he didn't get any help from him and Kashipur Police Station straightway refused to accept the complaint. Finally finding no such alternatives, he has intimated a written complaint to the Superintendent of Police, Purulia District through registered post on 02.12.2022 and to the Officer- in -Charge, Kashipur Police Station but still now no such action has been taken as yet by the Officer- in -Charge, of Kashipur Police Station, DistPurulia.
- 7. That this case prima facie shows the involvement of such illegal act are threat to the society as a whole as the complainant would certainly not be the only victim of these accused persons. This is a case in which the proper police investigation is required. However, police has not taken any action nor registered the FIR in this matter because of the reasons best known to them.
- 8. The complainant and his family are shocked at this act of theft and or criminal force to the complainant by the accused persons and complainant has undergone metal agony and social hardship by facing such type of situation at present.
- 9. That from the conduct of the accused persons, i.e. the 'modus operandi' since the inception/very beginning, the complainant is suffering irreparable loss and injury, the accused person committed the offence under sections of the Indian Penal Code. Thus it is evident from the above noted facts that the accused persons intentionally committed the offence under sections 379/447/323/506/120B/34 of the Indian Penal Code
