Sub: To lodge FIR against owner and driver of seized tractor one Mahindra 265 DI (Red Colour) tractor having Chassis No MBNABACAANRM09848 and Engine No RNM2BBN0212 along with trolley (without number plate) loaded with sand approx 55-60 Cft.

Sir.

In producing herewith one arrested accd. person namely Suprim Halder (26 yrs) s/o - Chandi Charan Halder of Vill- Gourangdi, PS- Kashipur, Dist — Purulia, driver of Tractor(without number Plate) having Chassis No MBNABACAANRM09848 and Engine No RNM2BBN0212 along with trolley (without number plate) loaded with sand approx 55-60 Cft (iii) 02 piece old Iron made "Belcha" having iron butt and (iv) 02 piece iron made "Dhama" before you.

The nub of the fact in a nutshell is that on 07.01.2023 at 16.15 hrs. I, SI Pratap Ch. Ojha of Kashipur PS along with (i) C/628 Giridhari Bauri and (ii) C/730 Tapas Mandal both of Kashipur PS, Dist - Purulia, left the PS for performing evening mobile duty at Kashipur P.S area vide Kashipur P.S GDE No- 262 dt- 07.01.2023 and C.C No. 61/23 Dtd. 07.01.2023. During my mobile duty, I received a tip off at 17.55 hrs that some persons were loading a tractor with sand from the river bed of Dwarkeswar River near Sutaboi village under Kashipur P.S. Subsequently, I along with force moved to the spot. We kept the vehicle on the bank of river and proceeded towards the spot by foot. We reached on the spot at 18.45 hrs. We came to find that few persons were loading sand in the attached trolley of said tractor and one person was sitting on the driver's seat . We rushed to the Tractor and detained the said tractor and somehow we managed to apprehend the person who was sitting on the stirring of driver's seat. On interrogation he disclosed his name noted in the supra, who is the driver of said vehicle. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver of the said vehicle could not able to produce any kind of documents in respect of the Tractor and the sand. I repeatedly asked the driver to produce the valid paper but they stated different statement in different times. The incoherent statement of the drivers purported to be a suspicious one to us. It was ascertained that the driver of the said tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So I, seized Tractor (without number Plate) having (Trassis No MBNABACAANRM09848 and Engine No RNM2BBN0212 along with trolley (without number plate) loaded with sand approx 55-60 Cft (iii) 02 piece old Iron made "Belcha" having iron butt and (iv) 02 piece iron made "Dhama" in between 19.05 hrs to 19.25 hrs from his possession after preparing proper seizure list duly signed by available witnesses. Requested the driver to put his signature in the seizure list but he refused to put his signature on the seizure list. Arrested him on that spot after informing the ground of arrest and issued Memo of Arrest against him but he again refused to put his signature in the Memo of arrest. Informed his family members and friends regarding cause of arrest. Thereafter, I brought the said tractor to Kashipur P.S. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid documents in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owner and arrested driver of above noted tractor along with the trolley for investigation.
