Sub: To lodge FIR against owner and driver of (i) Power trac 439 RDX (Blue Colour) tractor having, Engine No E3627746, Chassis No T053559504DK(Without Number plate) along with trolley (Without number plate) loaded with sand approx 60 - 65 Cft

Sir,

In producing herewith tractor i.e. (i) Power trac 439 RDX (Blue Colour) tractor having, Engine No E3627746, Chassis No T053559504DK(Without Number plate) along with trolley (Without number plate) loaded with sand approx 60 - 65 Cft and (ii) 02 pieces old Iron made "Belcha" having iron butt (iii) 02 pieces Iron made "Dhama" before you.

The nub of the fact in a nutshell is that on 21.01.23 at 16.45 hrs. I, SI Jagannath Saha of Kashipur PS along with (i) C/793 Prasanta Patra and (ii) C/157 Dipak Bauri both of Kashipur PS, Dist-Purulia, left the PS for performing mobile duty under Kashipur P.S area vide Kashipur P.S GDE No 842 Dtd - 21.01.23 and C.C No. 179/23 Dtd. 21.01.23. During my mobile duty, I received a tip off at 19.45 hrs. that some persons were loading a tractor with sand from the river bed of Darkeswar River at Shyambathan Ghat near Shyambathan village under Kashipur P.S. Subsequently, I along with force moved to the spot. We kept the vehicle on the bank of river and proceeded towards the spot by foot. We came to find that few persons were loading sand in the attached trolley of a tractor at Shyambathan Ghat near Shyambathan village. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley) at Darkeswar River, fled away from the spot. We rushed to the Tractor and detained the said tractor. We searched the said tractor and found that the trolley is loaded with sand and also searched surrounding but could not trace out the persons & driver of said offending Tractor. Hence, I seized the above noted tractor along with trolley loaded with sand and other articles in between 20.35 hrs to 20.55 hrs and brought the said seized articles to Kashipur PS. As there is every reason to believe that the drivers and owners of the said tractors with ill motive were transporting sand illegally without any valid documents in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owner and driver of above noted tractor along with the trolleys for investigation.
