I do hereby lodge complaint empowered by enabling the electricity act-2003, subsequently electricity (Amendment) act-2007 to the effect that RADHASHYAM MAHATO , S/O:- LT. GOPESWAR MAHATO, resident at- KURIAM, PS:- Kotshila, Dist- Purulia was enjoying electricity unauthorized i.e. hooking from nearest LTOH line and due to this reason he-

has committed theft of electricity U/S 135 (1/a) of the electricity (Amendment act-2007) on...30.01.2023...at.....02.05. P.M.

and inspected his/ her premises. During the inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by drawing illegal hooking from the nearest LTOH line of WBSEDCL i.e. U/S 135(1/a) was detected.

From the above arrangement he/she uses the following electrical equipments.

Out of which I seized the following.

1. PVC two core cable fitted with hooking device approx length 12 feet's along with one bulb .

The accused person has committed an offence U/S 135(1)/(a) of the electricity act-2003 & subsequently electricity (Amendment) act-2007.
