Entered the premises of Tiruka Mandal S/O - Naran Mandal

and inspected his/her premises. During inspection theft of electricity was detected i.e. he/she  
was using electricity dishonestly by drawing illegal hooking from the nearest L.T.O.H line of  
W.B.S.E.D.C.L. i.e. U/S 135 (I) (a) was detected.

From the above arrangement he/she was using the following electrical equipments

- 2) 1 no Fan 80 watt = 1 x 80 = 80 watt.
