Sub:- Complain for starting a specific case .

Sir,

In producing herewith the seized dumper having registration No- WB 37A/8115 loaded with sand approx 400 Cft under proper seizure list. I beg to submit that I, SI Abhijit Das, along with C/399 Kartik Mura, NVF/189 Rampada Mandi and (3) NVF/530 Dilip Singh all are of Neturia PS were performing night mobile duty vide Neturia PS GD No- 274 Dt. 06.01.23 & CC No- 61/23 Dt. 06.01.23 at PS area and on 07.01.2023 at about 05:25 hrs received a credible source information that one dumper loaded with illegal sand coming from Madhukunda side towards Sarbari side. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately started Naka at Sarbari More and at about 05:55 hrs found that above noted dumper was coming from Madhukunda side and suddenly the driver stopped the dumper Near Shib Shakti Marriage Hall after seeing the police party then he got down from the vehicle and started running towards the village area. We chased to apprehend the person but in spite of hot chase he managed to flee away. Then we searched the vehicle and found that the vehicle (Dumper) having registration No- WB 37A/8115 has been loaded with sand approx 400 Cft.

So, there is reason to believe that the driver and registered owner of the vehicle have collected the said sand either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same sand in a clandestine manner to Barakar side knowing it to be stolen.

Accordingly, I seized the Dumper bearing No WB 37A/8115 loaded with sand approx 400 C.Ft. at 06:15 hrs under proper seizure list duly signed by witnesses. So, the driver and registered owner of the dumper have committed offence U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957.

Under the above fact and circumstances a specific case may kindly be started against driver of dumper No- WB 37A/8115 and registered owner the dumper No. WB 37A/8115 U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957 and arrange its investigation.
