Sub: Complain to start a specific case.

Sir,

In producing herewith one arrested accused person namely Sk. Rafiul (40 Years) S/O- Lt. Sk. Haru of Vill-Murulia, PS-Santuri, Dist-Purulia with seizure list Dt. 26.01.23 along with raw coal seems to be steam approx 12 MT, Belcha-04 pieces, iron made Dhama – 04 pieces, Sabal – 02 pieces, kopicol-01 piece, Nylon Rope-approx 50 feet & bamboo- 11 pieces, do hereby lodge a complaint to the effect that today on 26.01.23, I, ASI Rajkumar Goswami, along with C/399 Kartik Mura, C/898 Partha Musib, C/2861 Tapan Khan, C/948 Ramen Paramanik, HG/1952 Dhananjay Das and VP/108 Sanjoy Kumbhakar all are of Neturia PS Dist Purulia were performing mobile duty at Murgaboni area vide GDE No- 1160 dt. 26.01.23 & CC No-254 Dt. 26.01.23 and at about 15:05 hrs found some people engaged in procuring illegal coal from illegal pit situated at Murgaboni Mouza (Lat-23.6207300 & Long-86.8368330). Seeing the police team, they started to run from the spot. We chased them and after hot chase managed to apprehend the above noted accused person. On being asked to produce any valid document in support of coal, he failed to produce any valid document. Accordingly I seized raw coal seems to be steam approx 12 MT, Belcha-04 pieces, iron made Dhama – 04 pieces, Sabal – 02 pieces, kopicol-01 piece, Nylon Rope-approx 50 feet & bamboo- 11 pieces from his possession under proper seizure list duly signed by him and witnesses. Accordingly I arrested him after maintaining arrest rule and on interrogation he disclosed the name of his accomplices as (1) Sk. Mana S/O- Sk. Samu (2) Sk. Asiruddin S/O- Sk. Bunali (3) Sk. Ismail S/O- Sk. Usman (4) Sk. Jahir S/O- Sk. Saharab (5) Sk. Jamal S/O- Sk. Dulal all are of Vill-Murulia, PS-Santuri, Dist-Purulia and (6) Bimal Kisku S/O- Chhotolal Kisku of Vill-Santalmoutha, PS-Neturia, Dist-Purulia & others who were engaged in procuring illegal coal from illegal coal pits and transporting the same in a clandestine manner to another district/state.

So, it is reasonable to believe that the arrested accused (1) Sk. Rafiul (40 Years) S/O- Lt. Sk. Haru and his accomplices (2) Sk. Mana S/O- Sk. Samu (3) Sk. Asiruddin S/O- Sk. Bunali (4) Sk. Ismail S/O- Sk. Usman (5) Sk. Jahir S/O- Sk. Saharab (6) Sk. Jamal S/O- Sk. Dulal all are of Vill-Murulia, PS-Santuri, Dist-Purulia and (7) Bimal Kisku S/O- Chhotolal Kisku of Vill-Santalmoutha, PS-Neturia, Dist-Purulia & others had obtained the said coal either by theft or by any fraudulent means from the illegal coal pits and trying to dispose the same coal in a clandestine manner to another district/state knowing it to be stolen. After seizure necessary arrangement has been made for shifting the seized coal at Neturia PS.

Therefore, I pray that a specific case may kindly be registered against accused (1) Sk. Rafiul (40 Years) S/O- Lt. Sk. Haru (2) Sk. Mana S/O- Sk. Samu (3) Sk. Asiruddin S/O- Sk. Bunali (4) Sk. Ismail S/O- Sk. Usman (5) Sk. Jahir S/O- Sk. Saharab (6) Sk. Jamal S/O- Sk. Dulal all are of Vill-Murulia, PS-Santuri, Dist-Purulia and (7) Bimal Kisku S/O- Chhotolal Kisku of Vill-Santalmoutha, PS-Neturia, Dist-Purulia & others under proper section of law.
