I the undersigned would like to inform you that Iam an advocate by profession. on 21.01.2023 after coming back to my home from court, I noticed that some of my files and documents are in scattered conditions and after going upstairs suddenly I noticed that the lock of a room in the 1<sup>st</sup> floor of my elder brother namely Amal Shaw is broken and entering into the room I found the lockers of the almirah are broken and all the household articles were not in proper order.
