Sir,

I do hereby lodge written complaint empowered by enabling the electricity act 2003 subsequently amendment act 2007 to the effect that Sri Tarani Taran Mahato ,S/O-Sri Banshidhar Mahato , Village-Radhanagar,P.O.-Bagda,P.S.-Puncha, Dist-Purulia ,Pin- 723151 has committed theft of electricity under section-135 clause (1)(b) of the electricity act subsequently amendment act-2007 on 17.01.2023 at about 01:30 P.M.

I Sri Saikat Mallick,S/O-Himadri Mallick,A.E & S.M of Puncha CCC along with 1)Sri Biswanath Barui, A.E.(S&LP),S/O: Sri Swadesh Ranjan Barui ,Purulia Regional Office ,2) Sri Somnath Soren(J.E Gr-I) under puncha CCC ,S/O-Lt. Pannalal Soren 3)Sri Sandip Mahato(O.E.) under Puncha CCC,S/O-Lt. Brindaban Mahato,4)Dayamoy Mahato,Sr. T.S.H.,S/O: Lt Chutulal Mahato, Purulia Regional Office and other technical staff attached to Puncha CCC entered the premises of Sri Tarani Taran Mahato ,S/O-Banshidhar Mahato , Village-Radhanagar,P.O.-Bagda,P.S.-Puncha, Dist-Purulia ,Pin- 723151 a consumer of Puncha CCC having Consumer ID- 203318459, Meter No-L05734530 and inspected his premises .During the inspection theft of electricity was detected by the way of bypassing the energy meter of WBSEDCL of serial no- L05734530 under section 135(1)(b).

The accused person was consuming electricity dishonestly at his domestic premises by the way of by tampering and bypassing the energy meter of WBSEDCL without registering the actual consumption causing considerable revenue loss of WBSEDCL ,during inspection total load found was 1.021KW.From the above bypassing system he uses the following electrical equipments-

- 1) Water Pump-01 no(746 Watt ) Fan-02 nos(80 Watt each) 3) light-5 nos(07 Watt each) 4)TV-01 no(80 Watt).

The following items were seized from the house of the accused person-

1)01(one)no single phase energy meter make Landis Gyr bearing Meter No- L05734530 with broken seal no-3374892 with bypassing arrangements with 2core PVC cable approx 2(Two)meters.

Seizure list was prepared at the site and the accused person refuses to sign. The inspection team left the premises at about 01:50P.M. On 17.01.2023.The accused person has committed an offence U/S 135 (1)(b) of E.A-2003 subsequently amendment E.A-2007.You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
