That ,the Complainant happens to be a permanent resident village- Burudih, P.O – Shibdih, P.S – Purulia(M), in this district having his hearth and home thereat.

2. That on 10/03/2022 at about 1.30 P.M to 2.00 P.M when my father was standing near Imundih More near Pandey line Hotel waiting for bus suddenly one vehicle Vide its registration No JH 09 AR 2854 comming from Purulia side dashed my father namely Ajit Gope and ran way towards chasmore side and my father fell down on the ground and the persons hotel and the co villagers took my father to Purulia Deben Mahato Sadar Hospital and admitted therein and my father had been referred for better medical treatment and I along my family member took my father to Bokaro General Hospital and there after referred to Global Hospital Ranchi on 16/03/2022 and on 19/03/2022 my father expired due to the rash and negligent driving of the Driver vide Registration No JH 09 AR 2854 .

That on the same day the complainant had informed the matter I/C of Purulia(M) P.S and the complainant narrated the matter before officer on duty of Purulia (M) P.S and the same was reduced in writing and was submitted to the Police officer of Purulia(M) P.S on 20/03/2022 and the written complaint had been sent before Purulia (M)P.S On 17/11/2022 but as no action had been taken against the accused till 01/12/2022, and thereafter your Petitioner/Complainant intimated the matter in writing before Superintendent of Police, Purulia on 02/12/2022 but that too failed to evoke any response.
4. That the accused person have committed several offences of the Indian Panel Code which warrant police investigation into the case
