Sir,

I Sri Sunil Chandra Kar, son of Late Patit Paban Kar, and Sabita kar, wife of Sunil Chandra Kar, resident of Deshbandhu Road, Bal Bharati School lane, Purulia lodge this Diary against Samir Karmakar, son of Sri Gepal Karmakar of Village- Nadiara, P.O- Nadiara, P.S- Purulia (M), District- Purulia, on the following facts against his nefarious activities by squeezing money from me on the plea of selling Land.

That we are Retired Government Employee. One Samir Karmakar, son of Gopal Karmakar who deals in Real Estate Business came before us in the last October, 2020, and showed us a General Power of Attorney executed by Ananda Roy, son of Late Sibu Roy and 5 others in his favour dated 06/04/2018 empowering him to sell Land of the Property bearing R.S Plot no. 3779 of Mouza- Lagda. I was swayed away by his words and he stated that he will sell 10 decimals of Land out of R.S Plot no. 3779 appertaining to R.S. Khatian no. 849 of Mouza- Lagda for a sum of Rs. 2600000.00 (Rupees Twenty Six Lakhs). I perused the paper and did not suspect any foul play and accordingly on 12/10/2020 I paid Rs. 600000.00 (Rupees Six Lakh) to him, and on 13/10/2020 I paid Rs. 400000.00 (Rupees Four Lakh), and on 17/10/2020 and on 18/10/2020 I paid him a sum of Rs. 100000.00 (Rupees One Lakh) and Rs. 500000.00 (Rupees Five Lakh) respectively. On repeated request made by Samir I on 31/10/2020 paid a sum of Rs. 200000.00 (Rupees Two Lakh) and on 27/11/2020 I further paid a sum of Rs. 800000.00 (Rupees Eight Lakh) to Samir Karmakar. All the payments amounting to Rs. 2600000.00 (Rupees Twenty Six Lakh) were made through NEFT & RTGS. On his further demand I paid him cash of Rs. 200000.00 (Rupees Two Lakh) for drafting the Deed of Sale and for Registration. He further promised to us that as he is a resident of Nadiara so he will make arrangement for Boundary Wall and for labelling the Land and on that score he took a further sum of Rs. 400000.00 (Rupees Four Lakh) from me. That thereafter we requested him to execute and register a Sale Deed for which the entire money was paid but he cunningly deferred the matter which causes suspicious to me. I thereafter took out a certified copy of the Khatlan and came to learn that R.S Plot no. 3779 of Mouza- Lagda does not belongs to the Roy family but it belongs to Mahato family i.e. one Sahebram Mahato and others. When we pointed out the same to Samir Karmakar he admitted his fault and stated to that he will execute a Deed of Partnership and accordingly the said Samir Karmakar got a Partnership Deed executed before Notary Public, Lal Mohan Mahanty, in which Samir Karmakar stated that the profits will be divided half and half and he further admitted that he has taken money and the said Partnership Deed was executed on 28/01/2021 but however after some days it was realised that I was the victim of fraud and deception. We requested Samir Karmakar to pay back/return back the total money which was paid to him but he
