(v)Exhibit Mark C-one lock of "Shobha Dolphin" Company with key under proper seizure list, I SI Santosh Kr Roy of Santuri PS beg to submit that on 30/12/2022 myself along with other PS officers interrogated the PC accused namely Sk Kismat (29 yrs) S/O-Sk Abul Kalam of Vill - chepra, PS- Purulia (M), Dist-Purulia in c/w Santuri PS Case No-88/22, date-02/12/2022, u/s- 392 IPC at Santuri PS. He confessed his guilt and stated that he committed the crime with three other associates na nely 1. Sk Md Ushama, 2. Sk Samim @ Amin and 3. Papu Hela. He also added that he has a fire arms kept in a secret place in his house and he will help Police for recovery of the same. I have recorded his statement u/s 161 Cr.P.C. and the matter was diarized vide Santuri PS GDE NO - 1181, Dtd.- 30/12/2022 and at once the information brought to the notice of my immediate superior i.e. O/C Santuri PS and as per his direction myself along with 1. C/79Partha sarathi De, 2. C/1529 Bablu Tudu accompanied with PC accd Sk Kis nat (29 yrs) S/O-Sk Abul Kalam of Vill.-Chepra, PS-Purulia (M), Dist-Purulia moved to Purulia (M) PS to work out the information vide Santuri PS GDE No- 1181, Dtd.- 30/12/2022 and Santuri PS C.C. No - 4635, Dtd.- 30/12/2022. We reached at Purulia (M) PS at 01:15 hrs. On further interrogation he denied the matter of fire arms and stated that he uses to run illegal business of Codeine mixture for his wrongful gain in a clandestine manner and one bottle of Codeine mixture is kept at a lock and key trunk in his house and he will heip us to recover the same. Immediately I brought the matter under knowledge of O/C Santuri PS over mobile phone and he diarized the matter vide Santuri PS GDE No - 1184 Dtd.- 31/12/2022 and also the said matter was informed properly to I/C Purulia (M) PS and asking for Police help. Accordingly I submitted a requisition before you for rendering police help over holding raid and search as per leading statement of PC accd Sk Kismat of Vill.- Chepra, PS.-Purulia (M), Dist.- Purulia.

On 31.12.22 at 01:55 hrs we accompanied with I/C Purulia (M) PS, Shri Sanjoy Kr. Chakraborty Inspector of Police and SI Shoumik Acharyya, C/ 2498 Ranjan Kr. Samanta, & C/2505 Anup Kundu all of Purulia (M) PS with PC accd left for Chepra village under Purulia (M) PS for holding search as per leading statement of PC accd Sk Kismat (29 yrs) S/O-Sk Abul Kalam of Vill.- Chepra, PS- Purulia (M), Dist-Purulia. After taking necessary articles like white papers, Carbon Paper, Brown Papers, Pen, Stamp Pad, Electronic Weight machine, Drug Detection Kit, Sealing wax, Brass seal, Candle, Match Box etc.I would like to note here that I tried to make contact with Executive Magistrate of Purulia Sadar but none was available at that odd hour of night.

On 31.12.22 at 02:35 hrs after arrival at Chepra village under Purulia (M) PS we tried to get disinterested local witnesses but as the PC accd is a dangerous criminal, being frightened none turned up.

I/C, Purulia (M) PS being as Gazetted Officer issued notice to the PC accd Sk Kismat mentioning that whether he was willing to search the body of Gazetted Officer along with other accompanying officer and force. The content of the notice was read over to the accd person but he denied to do so.

willing to be searched his persons before any Gazetted Police Officer. The content of the notice was read over to the accd person. He accorded consent.

In presence and under your kind supervision, PC accused SK Kismat brought out one Tin made trunk from his room at his dwelling house and opened it by a key which was also kept at a hidden place. After opening the trunk a plastic bottle having blue cap containing liquid which seems as contraband like substance. After opening the bottle an aromatic smell was found and after test with the Drug Detection kit, it responds positive result of Codeine mixture. On demand PC accd Sk Kismat failed to produce any document in respect of storing of Codeine mixture. During interrogation he stated that he is habituated in dealing of such clandestine illegal business of Codeine mixture for commercial purpose for his wrongful gain knowing the same is a punishable offence. Then I weighted the bottle and it results 1.696 Kg in Electronic Weight machine. On reasonable belief, an offence has been committed in respect of recovered liquid substance believe to be Codeine from which 100 gm was taken as test sample in two bottles of 50gm each.

In between Q3;25 hrs to 04: 35 hrs, I prepared seizure list in respect Exhibit Mark – A, A1, A2, B and C containing 1500 ml Codeine Mixture, 50 ml Codeine Mixture, 50 ml Codeine Mixture, one old tin made trunk approx length 2(two) ft and one lock of "Shobha Dolphin" company with key respectively and labeled the same in presence of you and other witnesses as well as accd person duly signed by each of them. I served copy of seizure list to the accd person. The entire search and seizure process was video graphed.

The accd person is liable for prosecution u/s 21 (c)/29 of NDPS Act, 1985 as amended up to date.

In this circumstance I request you to initiate a case against Sk Kismat (29 yrs) S/O-Sk Abul Kalam of Vill.- Chepra, PS- Purulia (M), Dist-Purulia u/s 21 (c)/29 of NDPS Act, 1985 as amended up to date and arrange for its investigation.
