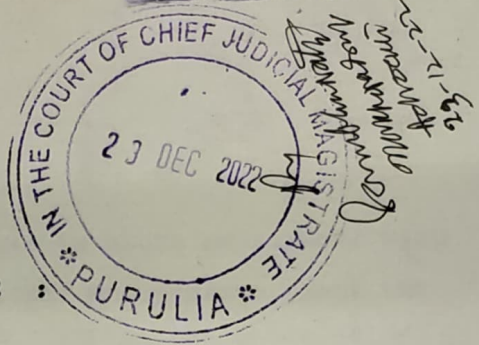

beg to state :-

1. That, I am filing this case against the Accused persons above named.



Mymarriage was solemnised with one Rahima Bibi, third(3) daughter of Sk. Akkas Gatageria, of Village Hariharpur, P.O. Sankra(B), P.S. <sup>Para</sup> Para, District- Purulia on 01-07-2021 as per our rites and customs prevalent in our Society. At the time of marriage there was no demand of either side. After the marriage my wife - Rahima Bibi ~~wase consumated~~ came to my house and our marriage was consumated. It is mentioned that when my wife Rahima Bibi entered my house, she was received and presented some ornaments such as one pair of Golden Ear Makri weighing eight annas, one Golden nose Nath weighing six paisa, one Golden Kallafull weighing one Ana, ~~one Golden~~ Three pairs of Silver Banggles weighing Nine Tolas, one pair of Silver Jhapta weighing Seven Tolas, one Silver Jhota weighing 5 Tolas, one Silver Neck Chandrahar, weighing six tolas, one pair of Silver Leg Barasut weighing six Tolas, the cost of all these ornaments was about Rs. 2,00,000/- (Rupees Two Lakhs). In our peaceful conjugal life my wife delivered a male child It is mentioned that after ~~our~~ our marriage my wife Rahima Bibi preferred to remain in her patrimonial house. After the birth of the child I took my wife with the child to my house and thereafter I requested Rahima Bibi not to go to her father's house frequently which did not suit her and she sometimes became violent and disagreement cropped up between us. Rahima Bibi sometimes

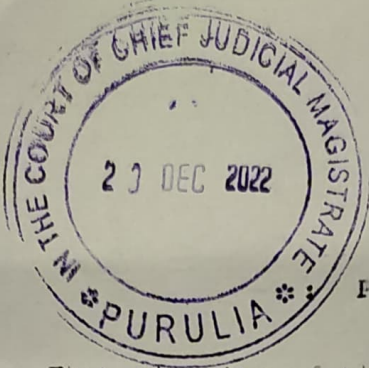

used to assault me and use to abuse my parents with filthy languages I informed her parents about the conduct when sometimes her father and other relatives used to come to my house and secretly met my wife and sometimes my wife gave them certain house hold articles and even money but as a gentleman I did not inform anybody the conduct of my wife. My wife caused damaged to my house hold articles after throwing these, she did not remain peacefully with me intentionally. Some times her Sisters Maharuma Khatun and Saharuma Khatun threats me in abusive languages, threat me to implicate me and my relatives with false cases and even told me that they would murder me. My wife used to keep in her mouth tobacco inside her mouth and the smell of which I could not tolerate. My father-in-law took from Rs. 25,000/- with promise to return on my demand but he did not return me back my said money.



On 17-07-2022 at about 3 P.M. elder brother of Rahima Bibi (1) Sk. Mobarak, Son of Sk. Akkas Gatagaria, (2) Sk. Akkas Gatagaria, Son of Late Sk. Nayeb Gatagaria, (3) Kamela Bibi, wife of Sk. Akkas Gatagaria, (4) Saharuma Khatun, (5) Maharuma Khatun, both are daughters of Sk. Akkas Gatagaria. (6) Sk. Rafikul, Son of Sk. Akkas Gatagaria, all are of Village Hariharpur, P.O. Sankra(B), P.S. Para, District Purulia (West Bengal) in a body forming an unlawful assembly and being armed with Lathi, Tangi, spear, Iron Rod trespassed into our house and "marshalader, Katshalader bolitey, bolitey" assaulted my old parents by fist and blows and kicks and thrashed them on the ground, damaged almost all the house hold articles and caused a loss of about 15,000/- and asked my wife to take all the ornaments given by us to her and to go to her father's house with them and my wife went to her father's house taking the ornaments with them threatening us to file false case against us.

That, inspite of the incident on 17-07-2022 I again went to my matrimonial home on 11-9-2022 to take her considering future of my wife and my child but instead of cordial talk and reception with me they tied me with a rope and with intent to murder me as per their chance. I cried loudly when some neighbouring people came and untied me and saved but I do not know their names. My wife told me that she will not come to my house to live a happy peacefull life. I heard that Rahima Bibi did not allow my child to suck her breast milk.

That, so long I did not file any case for the offences committed by her and others as above but my wife and others are threatening me over phone and even my father-in-law came to my house before few days and threatened me to murder.

I lodged Complaint before the Officer-in-Charge, Purulia(M) P.S. and thereafter also before the S.P., Purulia but no action taken against my Complaint for which I am filing this Complaint before your Honour. I am a poor man have no means to conduct this case <sup>of my own fund</sup> and the incident is a serious one for which I pray that the Petition be admitted and sent to the O.C. of Purulia (M) P.S. and to start necessary case and report.
