

Sub: Complaint against Mritunjoy Bouri (32) s/o Lt. Mathur Bouri of Vill-Hutmura Bouri Para, PS-Purulia (M), Dist-Purulia to start a cog case u/s 46 A (c) of Bengal Excise Act. 1909.

Sir,

In producing herewith one arrested accd. person namely Mritunjoy Bouri (32) s/o Lt. Mathur Bouri of Vill-Hutmura Bouri Para, PS-Purulia (M), Dist-Purulia with seizure list and seized articles.

I beg to submit that today (28.01.2023) while I was detailed to perform Spl. Day Mobile duty in PS area along with force i) C/1175 Srikanta Mukherjee & (ii) C/2078 Haripada Das both are Purulia (M) PS & Purulia (M) PS C.C. No 308/2023 Dt. 28.01.2023. During my mobile duty, I received a secret tip off that an illegal possession of huge amount of Country spirit at Hutmura Bouri Para. Subsequently, I informed you and as per your direction, I rushed to the spot that Hutmura Bouri Para and after arriving at the spot and as per instruction conducted raid in the in the house of Mritunjoy Bouri at Hutmura Bouri Para under this PS at 12:45 hrs. During the raid 2/3 persons fled away from this house and detained one person namely Mritunjoy Bouri (32) s/o Lt. Mathur Bouri of Vill-Hutmura Bouri Para, PS-Purulia (M), Dist- Purulia. On asking the identity he disclosed his name address as noted supra. On interrogation he confessed that he possessed the Country spirit for selling illegally from his possession so that he could gain more amount from the selling of (liquors) Country Spirit. On demand he failed to produce any valid document in respect of selling and possession of said (liquors) Country Spirit from his house. Subsequently, I seized 18 (eighteen) sealed bottles liquors of country sprite each containing 600 ml., MRP 50/- per bottles which is styles as "Dil . Khush" and kept 01 sealed bottles as sample from 18 (eighteen) bottles under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. Consequently, I arrested the above noted accused person after informing him the ground of arrest and issued Memo of Arrest and observed all legal formalities in respect of the Arrest. The seized articles were properly sealed and labeled in presence of witnesses duly signed by them and accused person.

The above noted arrested person Namely Mritunjoy Bouri (32) s/o Lt. Mathur Bouri of Vill-Hutmura Bouri Para, PS-Purulia (M), Dist-Purulia committed offence U/S 46 A (c) of Bengal Excise Act. 1909 for unauthorized possession for selling of Country Spirit from his house. Under the fact and circumstance kindly take necessary lawful action against Mritunjoy Bouri (32) s/o Lt. Mathur Bouri of Vill-Hutmura Bouri Para, PS-Purulia (M), Dist-Purulia.
