


IN THE MATTER of an humble application on behalf of the complainant: -

MOST RESPECTFULLY SHEWETH:-


- That complainant, Priyanka Sahis is presently residing at her parental home at Desh Bandhu Road, Ashu Sahis Lane, P.O. & P.S. Purulia Town, Dist. – Purulia files this application after being denied of a fair investigation by the Officer-in-Charge of Purulia Town Women Police station and even by the Superintendent of Police, Purulia.
- That inspite of financial hardship parents of the complainant had brought her up by implanting human and moral values in life.
- 3. That on 28.11.2021 i.e., on 11th Aghran 1428 the complainant was given marriage with accused no 1 from her parental house as per hindu rites and rituals. It is pertinent to mention at the time of marriage as per demand of the accused no 2, 3, 4, 6 & 7 the parents of the complainant handed over Rs. 50, 000/-, golden ear ring, golden chain, siver anklet, bed, almairah clothes and several utensils.
- 4. That after marriage the complainant started residing at her matrimonial house at Haripara, Khatra, district Bankura and for 3-4 months she stayed there in peace.
- 5. That thereafter accused no 1 demanded further dowry of Rs. 50, 000/and asked her to bring the amount from her father, but the complainant
 expressed her father's inability to give such amount, subsequently,
 accused no 1 and accused no 2 and 3 started physical and mental torture
 upon the complainant. On several context accused no 1,2 & 3 assaulted
 the complainant with slap, fist and kicks. Even if she fell sick, she was
 neither taken to any doctor nor she was taken care off by the accused
 persons. Unfortunately, if she had to travel back to her parents for
 consulting any doctor for her health issues.
- That on 17.06.2022, when the complainant was 3 months pregnant, all
 the accused persons hatched up a conspiracy to drive her out of their



house, accused no 1 & 5 caught hold of the complainant by hair and hand and was dragging her out of her marital house but she protested and fought back to stay in her matrimonial house all the accused persons starting started assaulting the complainant by kicks, slaps and fist and accused no 1 also assaulted her with lathi. The complainant fell down on the ground and then the accused no 1 kicked her abdomen with intention to kill the baby inside. Hearing hue and cry neighbours arrived and they stopped assaulting, the complainant was suffering with severe abdomen pain and even vaginal bleeding and accordingly she got herself treated in Bankura Sammilani Medical college and hospital on 20.06.2022 with the help of her maternal uncle, who stayed at Patpur, Bankura.

- 7. That thereafter the complainant came to her parental house and for menacing health condition she was admitted at Purulia Deben Mahato Hospital on 02.07.2022, and doctors declared the conceived child is dead. All the accused persons named above are directly responsible for the death of the unborn child.
- That on several occasions my parents approached accused no 1, 2, 3, 5
 & 6 to start afresh but the accused persons out and out rejected their proposal.
- 9. That on 13.09.2022 accused no 1 came to the parental house of the complainant and hurled the complainant and her parents with filthiest possible language and when the complainant protested him, he tried to strangulate the complainant with a towel (Gamcha), somehow the father of the complainant rescued her.
- 10. That at the initial stage the complainant approached the O.C. of Purulia Town Women P.S. on refusal to accept her complaint, the complainant posted the complaint to the Officer-in Charge through a registered post dated 30.09.2022 but till day no action has been taken nor any complaint has been registered.
- 11. That the complainant thereafter submitted a written appeal to the Superintendent of Police Purulia which was received in his office on 14.11.2022. Nonetheless nothing fruitful happened.
- 12. That the instant complaint should be sent to the officer in Charge of Purulia Town Women P.S. u/s 156(3) Cr.P.C. for treating it as a FIR and to start a specific case against the alleged persons. To unearth the unvarnished truth a detailed investigation and probe is very much necessary.





It is therefore prayed that your Honour will be pleased to send this compliant u/s 156(3) Cr.P.C. to O.C. Purulia Town Women P.S. with further directions for its investigation to be done in the interest of justice.

And for this act of kindness, your petitioner in duty bound shall ever pray.
