Respected Sir,

In producing here with one arrested accused person namely (1) Md. Firoz Ansari (27 yrs) S/O- Md. Samim Ansari of Domohani Bazar, Soudagar Para, PS- Barabani, Dist- Paschim Bardhaman the driver of seized vehicle no. WB41H/7272 along with 01(one) seized vehicle No (1) one truck having Regd No- WB41H/7272 loaded with approx 20 Ton Coal, seems to be steam coal and also taken sample of 05 kg coal from truck to the effect that I ASI Biman Pandey along with NVF/797 Badal Singh Mura, HG/222 Alok Bauri , all are of Purulia (T) PS were engaged in 2<sup>nd</sup> special mobile duty at Purulia Town area on Ranchi Road (NH32) vide Purulia (T) PS CC No- 13 dated 02.01.2023 and PS GDE No 68 dated 02.01.2023 and at about 14:05 hrs stopped one (01) vehicle loaded with coal coming towards Purulia Town & detained the driver named above. I contacted with my I/C and informed the matter and as per kind order I interrogated the detained driver noted above and on demand he could not able to produce any valid documents in respect of loaded coal. I have directed him to produce the valid document through the owner or his representative at P.S by 16:30 hrs. on 02.01.2023. Till 16:30 hrs on 02.01.2023 none produce any valid document in respect of the aforesaid coal vide Purulia (T) PS GDE No- 77 dtd 02.01.2023. So, on preliminary enquiry it could be learnt that he with conspiracy of owner of said truck & others procured the said coal illegally from different places and were transporting the same in a clandestine manner to another district/state for wrongful gain. So, it is reasonable to believe that they were transporting the coal illegally after procuring by means of theft. Accordingly, I seized the above noted vehicle loaded with coal under proper seizure list duly signed by the accompanied Police persons in between 16:35 hrs to 16:45 hrs as there was no availability of any local person, as such I could not collect the signature of the local people in seizure list and during seizure I had taken 05 Kg coal from the major contraband of the said truck as sample. After that I arrested him at 16:50 hrs after observing all formalities regarding arrest. On suspicion ground said coal loaded truck by the said driver brought to PS after proper arrangement and kept at PS Campus.

Therefore, I pray that a specific case may kindly be registered against above noted one (01) arrested accused person (driver) and owner of the seized vehicle and other associates under proper
