In producing herewith one arrested accused person namely Malati Orang (42 Yrs) w/o Lt. Dilip Sir. Orang of Old Police Line, Dompara, Ward No- 10, PS- Purulia(T), Dist.- Purulia under arrest. alongwith following seized articles under proper seizure list and being labeled properly:-

(1) 25 (Twenty five) bottles of Country Spirit designed as 'Dil Se' (each bottle contains 600 ml of . country spirit having strength 80° UP and MRP is Rs 55/- being sealed properly) blended and bottled by Purulia Bottling Pvt. Ltd., Vill+ PO Lagda, Dist. Purulia, Pin 723149.

(2) Out of 25 (Twenty five) bottles 01(one) bottle is kept as sample.

I, SI Jayanta Maji, beg to report that while I was performing mobile duty vide Purulia (T) PS GDE No- 595 dated 11.01.23, at about 06:05 hrs received a secret telephonic information from source that one person namely Malati Orang (42 Yrs) w/o Lt. Dilip Orang of Old Police Line, Dompara, Ward No- 10, PS- Purulia(T), Dist.- Purulia is selling country spirit illegally at a higher price causing unlawful gain to her by unlawful loss to the purchasers from her dwelling house at Dompara.

Accordingly I informed the matter to I/C, Purulia (T) PS and after getting his permission myself alongwith my team consisting of C/3006 Prasanta Molla and NVF/797 Badal Sing Mura, LC/486 Sampa Gorai all of Purulia (T) PS proceeded to work out the information.

At 06:15 hrs. We reached at Dompara and keeping our Govt. vehicle at a reasonable distance we preceded towards Dompara as shown by the source from the distance and found that the said lady was selling Country Spirit as noted above to some persons, some persons were found drinking there. Seeing the police, all of them tried to flee away leaving some plastic glasses at the spot. On hot chase Seller could be nabbed. On interrogation she confessed her guilt as she was selling Country Spirit as noted above to the locals without having any authority at a higher price since long. She also failed to produce any license in favour of selling, keeping or possessing Country Spirit and the said person disclosed her identity as noted above. On search of the shop we found 25 (Twenty five) bottles of Country Spirit designed as 'Dil Se' (each bottle contains 600 ml of country spirit having strength 80° UP) blended and bottled by Purulia Bottling Pvt. Ltd., Vill+ PO Lagda, Dist. Purulia, Pin 723149. As such at about 06:35 hrs to 06:55 hrs I seized the above noted Country Spirit under proper seizure list in presence of witnesses after labeling and seal properly. I also took samples and arrested him at 07:05 hrs observing all the formalities as the said person committed an offence which attracts sec. 46 A (C) of B.E. Act 1909.

Hence, I pray before you to start a specific case against the above noted person under proper section of law and kindly arrange for its investigation.
