Sub: Prayer for lodging F.I.R. against arrested accused person Parameswar Orang (31 Yrs) S/o Lt. Suren Orang of Ward No-22, Sarbagan, Nepali More, PS- Purulia (T), Dist. - Purulia.

Sir,

In producing herewith one arrested accused person namely Parameswar Orang (31 Yrs) S/o Lt. Suren Orang of Ward No-22, Sarbagan, Nepali More, PS- Purulia (T), Dist. - Purulia under arrest alongwith following seized articles under proper seizure list and being labeled properly:-

- (1) 20 (Twenty) bottles of Country Spirit designed as 'Dil Khush' (each bottle contains 600 ml of country spirit having strength 80⁰ UP and MRP is Rs 55/- being sealed properly) blended and bottled by Purulia Bottling Pvt. Ltd., Vill+ PO Lagda, Dist. Purulia, Pin 723149.
- (2) Out of 20 (Twenty) bottles 01(one) bottle is kept as sample.

I, SI Jayanta Maji, beg to report that while I was performing evening mobile duty vide Purulia (T) PS GDE No- 926 dated 16.01.23, at about 17:45 hrs received a secret telephonic information from source that one person namely Parameswar Orang (31 Yrs) S/o Lt. Suren Orang of Ward No-22, Sarbagan, Nepali More, PS- Purulia (T), Dist. - Purulia is selling country spirit illegally at a higher price causing unlawful gain to his by unlawful loss to the purchasers from his dwelling house at Sarbagan.

Accordingly I informed the matter to I/C, Purulia (T) PS and after getting his permission myself alongwith my team consisting of C/586 Bholanath Dey and C/420 Sk. Chand all of Purulia (T) PS proceeded to work out the information.

At 18:05 hrs we reached at Sarbagan and keeping our Govt. vehicle at a reasonable distance we preceded towards Sarbagan as shown by the source from the distance and found that the said person was selling Country Spirit as noted above to some persons, some persons were found drinking there. Seeing the police, all of them tried to flee away leaving some plastic glasses at the spot. On hot chase Seller could be nabbed. On interrogation he confessed his guilt as he was selling Country Spirit as noted above to the locals without having any authority at a higher price since long. He also failed to produce any license in favour of selling, keeping or possessing Country Spirit and the said person disclosed her identity as noted above. On search of the shop we found 20 (Twenty) bottles of Country Spirit designed as 'Dil Khush' (each bottle contains 600 ml of country spirit having strength 80⁰ UP) blended and bottled by Purulia Bottling Pvt. Ltd., Vill+ PO Lagda, Dist. Purulia, Pin 723149. As such at about 18:45 hrs to 19:15 hrs I seized the above noted Country Spirit under proper seizure list in presence of witnesses after labeling and seal properly, I also took samples and arrested him at 19:25 hrs observing all the formalities as the said person committed an offence which attracts sec. 46 A (C) of B.E. Act 1909.

Hence, I pray before you to start a specific case against the above noted person under proper section of law and kindly arrange for its investigation.
