Dear Sir,

I do hereby lodge complaint empowered by the Electricity Act 2003, Amendment of 2007 to the effect that, the below mentioned accused, has committed theft & unauthorized use of electricity U/S 135 1/b & 1/d of the electricity Act 2003, Amendment of 2007 as stated here under.

On 19/01/2023 at 12.05 Hrs. I, Biswanath Barui (AE S&LP attached to Purulia Regional Office WBSEDCL) along with Gopal Ch Goswami (Special officer attached to Purulia Regional Office WBSEDCL), Chinmay Maity (JE Purulia CCC), Anurag Pandey (OE Purulia CCC), Sankar Ch Mahato (ACM Purulia Regional Office WBSEDCL), Dayamay Mahato (Sr TSH Purulia Region Office WBSEDCL) went to make an inspection to workout upon a source information regarding theft of electricity for at the domestic premises of Bikram Kumar Jaiswal, Son of Jiban Kumar Jaiswal, resident of Chaibasa Road, Usha Machine Goll, Purulia(T) thana, Dist Purulia by serving one entry notice duly signed by the consumer.

During the time of inspection at the premises 2 nos of electricity meter were found having serial no L1477603 (Consumer id 242056797, Consumer Name- Jiban Kumar Jaiswal) & B4012455 (Consumer ID -201983108, Consumer Name- Bikram Kumar Jaiswal).

It was observed that consumer Bikram Kumar Jaiswal has made unauthorized use of electricity under section 135 1/b & 1/d by inserting foreign material in meter serial no B4012455, which works as resistance to interfere with accurate or proper registration of electricity consumption and hence causing huge loss of revenue to WBSEDCL. From the above arrangement the accused was using Fan 4 nos (60 watt each), Light 5 nos (9 watt each), Pump 1 nos 746 watt, Tv 1 nos 80 watt, Computer 1 nos 200 watt, Fridge 1 nos 200 watt, AC I nos 2250 watt.

After detection of theft & unauthorized use of electricity illegally and dishonestly, the inspection team disconnected both the service lines in the same premises from pole with the help of LT Mobile Van Team and removed & seized 1 nos of damaged energy meter bearing meter no B4012455. Prepared seizure list duly signed by the accused.

The inspection team left the premises at about 12:40 Hrs on 19th Jan 2023.

The accused committed theft of electricity U/S 135 1/b & 1/d of the electricity Act 2003, Amendment of 2007.

You are requested to take cognizance of the complaint & treat this as FIR and take necessary action.
