Sub: Prayer for lodging F.I.R. against arrested accused person Bhadu Rajwar (58 Yrs) w/o Lt. Sadhu Rajwar of Reny Road, Rajwar Para, Ward No- 21, PS- Purulia (T), Dist. - Purulia.

Sir,

In producing herewith one arrested accused person namely Bhadu Rajwar (58 Yrs) w/o Lt. Sadhu Rajwar of Reny Road, Rajwar Para, Ward No- 21, PS- Purulia (T), Dist. - Purulia under arrest alongwith following seized articles under proper seizure list and being labeled properly:-

- (1) 16 (Sixteen) bottles of Country Spirit designed as 'Dil Khush' (each bottle contains 600 ml of country spirit having strength 80⁰ UP and MRP is Rs 55/- being sealed properly) blended and bottled by Purulia Bottling Pvt. Ltd., Vill+ PO Lagda, Dist. Purulia, Pin 723149.
- (2) Out of 16 (Sixteen) bottles 01(one) bottle is kept as sample,

I, ASI Joydeb Atta, beg to report that while I was performing mobile duty vide Purulia (T) PS GDE No- 1225 dated 21.01.23, at about 13:05 hrs received a secret telephonic information from source that one person namely Bhadu Rajwar (58 Yrs) w/o Lt. Sadhu Rajwar of Reny Road, Rajwar Para, Ward No- 21, PS- Purulia (T), Dist. - Purulia is selling country spirit illegally at a higher price causing unlawful gain to her by unlawful loss to the purchasers from her dwelling house at Reny Road, Rajwar Para.

Accordingly I informed the matter to I/C, Purulia (T) PS and after getting his permission myself alongwith my team consisting of C/1429 Jagadish Ch. Mahato, C/236 Ram Chandra Garain and LC/1197 Faharat Jahan Khatun all of Purulia (T) PS proceeded to work out the information.

At 13:25 hrs. we reached at Reny Road, Rajwar Para and keeping our Govt. vehicle at a reasonable distance we preceded towards Reny Road, Rajwar Para as shown by the source from the distance and found that the said lady was selling Country Spirit as noted above to some persons, some persons were found drinking there. Seeing the police, all of them tried to flee away leaving some plastic glasses at the spot. On hot chase Seller could be nabbed. On interrogation she confessed her guilt as she was selling Country Spirit as noted above to the locals without having any authority at a higher price since long. She also failed to produce any license in favour of selling, keeping or possessing Country Spirit and the said person disclosed her identity as noted above. On search of the shop we found 16 (Sixteen) bottles of Country Spirit designed as 'Dil Khush'(each bottle contains 600 ml of country spirit having strength 80⁰ UP) blended and bottled by Purulia Bottling Pvt. Ltd., Vill+ PO Lagda, Dist. Purulia, Pin 723149. As such at about 13:45 hrs to 13:55 hrs I seized the above noted Country Spirit under proper seizure list in presence of witnesses after labeling and seal properly. I also took samples and arrested him at 14:15 hrs observing all the formalities as the said person committed an offence which attracts sec. 46 A (C) of B.E. Act 1909.

Hence, I pray before you to start a specific case against the above noted person under proper section of law and kindly arrange for its investigation.
