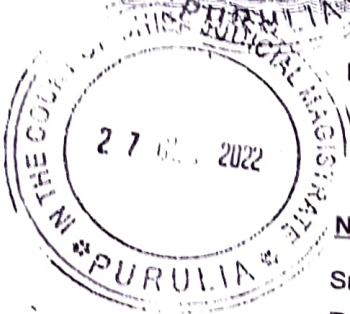

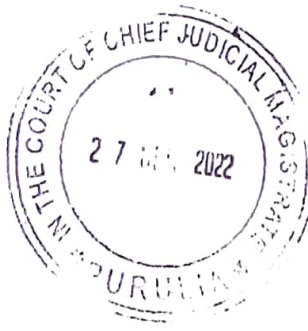

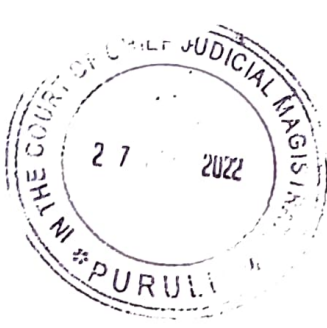

laborer and cultivation by profession, and father of Complainant permanently residing at Purulia Town, Nadiha Purulia and Complainant has two brothers and a sister i.e. complainant herself and they have landed property situated at Mouza Belguma and Nadiha, and Complainant has no demand regarding landed property of her parents but due to the Complainant is very poor and her sons financial condition were/are very low, taking advantage her near nephew namely Sanjit Mahato i.e. Accused No.1 most illegally and wrongfully manage to the Complainant and advised him she has own landed property at Mouza Nadiha and Belguma, and Accused No.1 want to obtain certified copy of the said landed papers and as the landed papers obtained from the Govt. Office so it is required for signature or L.T.I and Complainant has agreed and her sons are also agreed for the purpose of obtaining the land documents from the Government Office. On request of the Accused No.1 the Complainant and her son went to house of the Accused No.1 on 08.03.2022 but some unknown persons were present on the same day at about 12:00 Noon and the Accused Persons request to the Complainant to put her L.T.I in the blank paper and also requested to the son of the Complainant to mention by the pen of Complainant as son of the Complainant is literate on request son of Complainant also mention by the pen of her mother and after eating breakfast Complainant and her son both were went to their own house at Boro without informed to father's house of the Complainant or her brothers but in the month of July 2022 Complainant received a notice from B.L.&L.R.O. Purulia I for mutation her name against her two brother namely Nilmadhab Mahato and Bholanath Mahato which the Complainant beyond the knowledge and date fixed for hearing on 03.08.2022 and the said hearing was adjourned on 14.12.2022 and thereafter adjourned on 20.12.2022 fixed for hearing on 20.12.2022 the Complainant herself was present and requesting to the B.L.&L.R.O. Purulia- I for withdrawal the petition because she has no knowledge regarding mutation but the B.L.&L.R.O. Purulia-I deferred the matter on some pretext or otherwise and thereafter on 22.12.2022 Complainant sent a letter prayer for withdrawal the Misc Case No. 64 of 2022 before the B.L.&L.R.O. Purulia-I.

Be it mentioned here, that 19.12.2022 the Complainant has come to learn that the Accused Persons No.1 transferred her property in favour of Accused No.2 by Registered Deed being Deed No. 2537/2022 dated 30.05.2022 but neither

Accused No.1 informed to the Complainant nor he inform or gave knowledge regarding the sale deed or Power of Attorney nor comply any point of power of Attorney so as the Complainant is a widow and senior citizen helpless and illness neither she has any knowledge regarding power of attorney or deed of sale nor she has physically or mentally fit in the month of March, 2022 taking advantage the Accused Persons want to grab the property of the Complainant which mentioned in the schedule of the petition so the Accused Persons are cheated to the Complainant with the help of some unknown persons.

- 2) That, thereafter on 21.12.2022 Complainant has lodged complainant before the Purulia Town Police Station being GDE No. 1341 dated 21.12.2022 but Concern Authority did not take any step against the Accused Persons till 24.12.2022 so the Complainant sent letter to the S.P. Purulia by Register Post on 24.12.2022 but till now there is no such any action against the Accused Persons so the Complainant file this petition before this Ld. Court and prayed for treat this petition as FIR. All the Xerox copy of the documents attached herewith. Value of the property is not less than 1 (one) Crore.

It is prayed, that your Honour would be pleased to admit the petition and send this petition to I.C. Purulia Town P.S. and directing him to treat this petition as F.I.R. against all the accused persons and also pass necessary order which will deemed fit and proper.
