Respected Sir,

In producing here with one arrested accused person namely (1) Tuibul Ansary(35 yrs.) S/O Makbul Ansary of Purulia Loharpara, Ward No. 16, P.O Namopara, P.S Purulia (T), Dist. Purulia the driver of seized vehicle no. WB55B/6614 along with 01 (one) seized vehicle No (1) one truck having Regd No- WB55B/6614 loaded with approx 20 Ton Coal, seems to be steam coal and also taken sample of 02 kg coal from makor Contraband of the said truck to the effect that I ASI Nayan Ch. Mandal along with C/3006 Prasanta Malla and NVF/188 Arup Mahato, all are of Purulia (T) PS were engaged in 3rd Night mobile duty at Purulia Town area on Dulmi Road (NH-32) at Dulmi-Nadiha more vide Purulia (T) PS CC No- 278/23 dated 29.01.2023 and PS GDE No 1727 dated 29.01.2023 and at about 02:05 hrs. on 30.01.23 stopped one (01) vehicle loaded with coal coming towards Purulia Town & detained the driver named above. I contacted with my I/C and informed the matter and as per kind order I interrogated the detained driver noted above and on demand he could not able to produce any valid documents in respect of loaded coal. I have directed him to produce the valid document through the owner or his representative at P.S by 10:30 hrs. on 30.01.2023. Till 11:00 hrs on 30.01.2023 none produce any valid document in respect of the aforesaid coal vide Purulia (T) PS GDE No- 1757 dtd 30.01.2023. So, on preliminary enquiry it could be learnt that he with conspiracy of owner of said truck & others procured the said coal illegally from different places and were transporting the same in a clandestine manner to another district/state for wrongful gain. So, it is reasonable to believe that they were transporting the coal illegally after procuring by means of theft. Accordingly, I seized the above noted vehicle loaded with coal under proper seizure list duly signed by the accompanied Police persons in between 11:45 hrs to 11:50 hrs as there was no availability of any local person, as such I could not collect the signature of the local people in seizure list and during seizure I had taken 02 Kg coal from the major contraband of the said truck as sample. After that I arrested him at 11:52 hrs after observing all formalities regarding arrest. On suspicion ground said coal loaded truck by the said driver brought to PS after proper arrangement and kept at PS Campus.

Therefore, I pray that a specific case may kindly be registered against above noted one (01) arrested accused person (driver) and owner of the seized vehicle and other associates under proper section of law.
