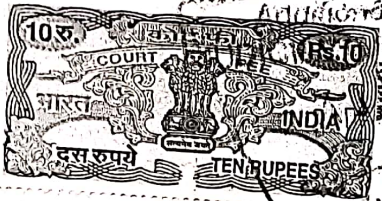

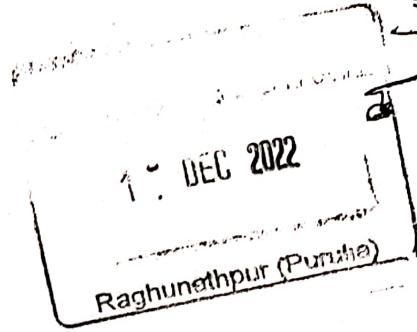

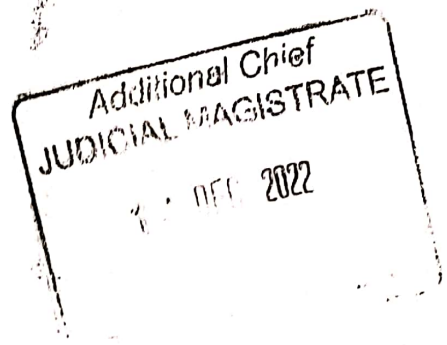
**PLACE OF OCCURANCE :**

**PETITION U/S 156(3) OF CR.P.C.**

**OFFENCE COMMITTED U/S 323/325/379/448/341/120B/34 of IPC.**

The humble petition on behalf of your complainant  
Most respectfully begs to sheweth as follows:

1. That your complainant is gentle, genuine and peace loving citizen of his locality and has been maintaining his family members in hardship.
2. That the accused no. 1 is the daughter in law of your complainant and the marriage was registered on 14.12.21 between the witness no. 2 with the accused no. 1 before marriage register Ardhendu Mitra It is here to be mention that the marriage was dowry free and there was no financial transaction between the family of your complainant and accused person no.1 and her family members.
3. That the accused no. 1 is a working lady and living separately from the witness no. 2 but your complainant and her family members i,e the other accused persons are have vulture eye over the house and property of the complainant, the accused persons on several occasions tried to fulfill their ill motive to grab the entire property of the complainant by the help of their masculine anti socials.
4. That several times, the accused person no. 1 by the instigation of the other accds. Tortured the complainant and his family members and lastly on 22/11/2022 at about 7:00 P.M. the accused person no. 1 by the instruction of other accds along with 2 unknown miscreants



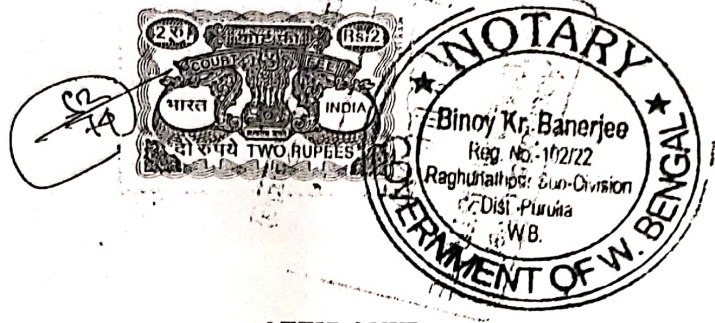
- also assaulted your complainant by fist and blows causing swelling injuries at various parts of the body.
5. That thereafter at the time of leaving the house of your complainant the accused person no. 1 stolen all the gold ornaments from the almirah of your complainant weighting about 4 bhari and Cash of Rs.1,12,000 (one lakh and twelve thousand) only.
  6. That the complainant with the help of the local peoples and the witnesses went to the local investigation centre on the same day and informed the matter but the police personnel did nothing rather advised to take shelter of Court of Law and the accused persons are still roaming about freely and continuously threatening the complainant as well as the witnesses.
  7. That having seeing the neglecting attitude of the local police authority and finding no other alternative the complainant compelled to file this complain before the Ld. Court for seeking justice for the protection of life.
  8. That thereafter your complainant lodge complainant before the Superintendent of Police, Purulia on 12/12/2022.
  9. That the delay is due to treatment of your complainant and expectation from the Police.
  10. That the details will be submitted at the time of the trial.
  11. That the accused persons have committed offence U/S 323/325/379/448/341/120B/34 of IPC.

It is therefore prays that your Honour may graciously be pleased to send to this petition of Complaint to the O.C. Raghunathpur P.S. with a direction to treat the same as F.I.R. U/s 156 (3) of Cr. P.C. and to file its report to the Ld. Court for the ends of Justice.
