In producing herewith the arrested accused person namely Gunadhar Hazra (21) S/o Kalachand Hazra of Vill.- Sindurpur, PS – Santaldih, Dist.- Purulia, driver of dumper No. WB 03C/7532 and seized dumper No. WB 03C/7532 loaded with approx 600 Cft. Fact of the case in brief is that on 24.01.2022 myself along with C/682 Mahadeb Rajak, C/737 Haradhan Nayek and (3) C/680 Uttam Bauri all are Raghunathpur PS were performing Night Mobile Duty on Raghunathpur – Santaldih road and at about 05:05 hrs. received a source information that the above noted dumper loaded with sand was going towards Santaldih side. After receiving such information I informed the matter to IC Raghunathpur PS and as per his kind direction we had been to Raghunathpur – Santaldih road near at Kestapur more and waiting for the said dumper and at about 05:25 hrs found that the above noted dumper is coming from Raghunathpur side. We stopped the said dumper and on searching it is found that the said dumper was loaded with sand and on asking driver of the said dumper failed to produce any papers in respect of loaded sand as well as papers in respect of the said dumper. He also made incoherent statement in respect of possession of the said sand in his dumper which he was driving. So, it is reasonable to believe that the driver and owner of the said dumper collected the said sand either by theft or by any fraudulent means from anywhere and transporting the same to run clandestine business for wrongful gains. On interrogation the driver of the said dumper confessed his guilt. As such it is every reason to believe that the driver and owner of the said dumper No. WB 03C/7532 transporting sand illegally. As such I seized the dumper having registration No. WB 03C/7532 loaded with approx 600 Cft. stolen sand under proper seizure list duly signed by the accused driver. Also arrested the accused driver of above noted dumper namely Gunadhar Hazra (21) S/o Kalachand Hazra of Vill.- Sindurpur, PS – Santaldih, Dist.- Purulia after observing all formalities and narrating him the ground of arrest. No public witness was available there. Approx 01 (One) K.G. of Sand sealed & labeled as sample Sand from major contraband.

I therefore pray before you, kindly lodge an FIR against the driver namely Gunadhar Hazra (21) S/o Kalachand Hazra of Vill.- Sindurpur, PS – Santaldih, Dist.- Purulia and owner of the dumper bearing No WB 03C/7532 as per law and arrange for its investigation.
