Subject : Complaint regarding threat, criminal assault, illegal trespass, use of criminal force,

Respected Sir,

I Rapaprasad Hazra s/o Late Ananda Ram Hazra begs to state that I am the Purohit of the Temple of Sri Sri Khelai Chandi Mata Thakurani and Sri Sri Keshav Roy Jew Thakur. Today i.e. 29.01.2023 at around 11:00 AM while I was doing the Nitya Seva Puja in the premises of the Chandi Temple goons mainly Ashish Mandal S/O Late Kistopada Mandal, Rajkumar Mandal S/o Late Shyamapada Mandal, Jaidev Majee S/O Amulya Majee along with others illegally entered the premises of the Temple and stopped me in doing the Seva Puja. They forcefully pushed me, slapped me, and assaulted me. They caught me by the collar and physically attacked me. They also threatened to kill me. On 17.01.2023 a similar incident was orchestrated by these people especially Jaidev Majee which was immediately brought to your kind notice through a written complaint.

They also used extreme unparliamentary words causing serious damage to mind and body. They also threatened me and my family with death if I perform the seva puja. In view of the above I request you to kindly take necessary and stringent steps.
