In producing herewith the arrested accused persons namely 1) Jiten Pasi @ Chowdhury, (35) S/O Lt. Laxman Pasi @ Chowdhury of Chakbad (Ambagan), PS- Santaldih, Dist- Purulia 2) Gouranga Swarnakar (26) S/O Sukdeb Swarnakar of Dubra, Dhibar Para and 3) Kartik Swarnakar (30) S/O Sukdeb Swarnakar of Dubra, near Primary School both of PS - Para, Dist. - Purulia and seized articles. I beg to submit regarding the fact of the case in brief is that on 12.01.2023 at 01:35 hrs received a credible source information that a gang of criminals have assembled at Poradih football ground near Rajwar Basti under this PS to commit dacoity at STPS, Plant. This refers to Santaldih I.C. (BCW) GDE No.208, dated 12.01.2023. I shared this information to you and as per your order, I along with C/1183 Subhas Kundu, C/662 Dhananjay Pandey and C/29 Koushik Ghatak left to work out the information at 01.45 hrs with the govt. supplied kit box containing white cloth, torch, sealing wax, seal, papers, carbons, match box, candles etc. This refers to Santaldih IC (BCW) GDE No.209 dated 12.01.2023 and C.C No 73/23 dated 12.01.2023. I also communicated with night mobile force to come at Poradih football ground near Rajwar Basti for assisting the raid. I along with force reached at Poradih football ground near Rajwar Basti at 02:15 hrs. Prior to that I briefed forces regarding the information and checked out the plan. We placed ourselves in a reasonable distance. Their gossiping talk disclosed their plan for committing dacoity at STPS, Plant. I along with force reached to their place of assembly of the criminals. Surprisingly, the criminals noticed our presence and at once they started threatening us for not to proceed any more before them. We warned them loudly to surrender but they did not listen to us. Suddenly all the criminals started to run towards Poradih jungle side. We chased them and after a hot chase we could be able to intercept 03 (Three) accused persons and rest 3/4 others could be able to flee away and hide themselves in the dark of night. On asked the intercepted accused persons disclosed their identity as 1) Jiten Pasi @ Chowdhury, S/O Lt. Laxman Pasi @ Chowdhury of Chakbad (Ambagan), PS-Santaldih, Dist-Purulia 2) Gouranga Swarnakar, S/O Sukdeb Swarnakar of Dubra, Dhibar Para and 3) Kartik Swarnakar, S/O Sukdeb Swarnakar of Dubra, near Primary School both of PS - Para, Dist. - Purulia. During interrogation, they disclosed one of their partners who fled away as Sakimuddin Ansary, S/O Lt. Karim Ansary of Parbahal, PS - Santaldih, Dist. -Purulia. On asked, the arrested persons confessed their guilt and stated that they have assembled there and prepared themselves to commit dacoity STPS Plant. Accordingly, I arrested all the accused persons after observing all legal formalities. We searched all the arrested accused persons thoroughly. At the time of searching the following articles were recovered from the arrested accused persons 1. One iron made crowbar of which one side is sharp and another side is blunt, measuring length approx 30 inch and one black colour torch, measuring approx 12 inch recovered from the exclusive possession of arrested accused Jiten Pasi @ Chowdhury 2. 01 (one) Axe (length - 12 inch and breadth - 05 inch) with wooden handle (length approx 27 inch) and one blue colour nylon rope length measuring approx 25 ft, recovered from the exclusive possession of arrested accused Gouranga Swarnakar and 3. One knife, plastic butt, green colour recovered from the exclusive possession of arrested accused Kartik Swarnakar, I seized them under proper seizure list in presence of witnesses duly signed by them and labeled the same. As the place was lonely and time was dark hours of night, no public witnesses were available there.

Therefore I pray before you that a case may be started as per law and arrange for its investigation.
