Sub : Prayer for lodging FIR against accd. Abhay Kumbhakar (48 yrs) S/O - Lt. Haripada Kumbhakar of Vill- Ichhar, PS-Santaldih, Dist- Purulia, U/S 46A (c) B.E. Act 1909.

Sir,

In producing herewith arrested accused Abhay Kumbhakar (48 yrs) S/O - Lt. Haripada Kumbhakar of Vill- Ichhar, PS-Santaldih, Dist- Purulia, along with 20 bottles seized country spirit styled as "DIL KHUSH" 600 ml in each bottle. I beg to state that today i.e on 30.01.2023 at 17.25 hrs acting on a tip off I along with force had been to the house of Abhay Kumbhakar (48 yrs) S/O - Lt. Haripada Kumbhakar of Vill- Ichhar, PS-Santaldih, Dist- Purulia. This refers to Santaldih I/C BCW GDE No- 517 and C.C No- 177/23 of dated 30.01.2023. I along with force held raid in the house of Abhay Kumbhakar. Seeing police van some unknown persons coming out from the house of Abhay Kumbhakar fled away. However I could be able to intercept Abhay Kumbhakar. On search found 20 bottles country spirit styled as "DIL KHUSH" 600 ml in each bottle in his house. I also found approx 15 empty bottles of country spirit styled as "DIL KHUSH" scattered at the courtyard of his house. On asked he failed to produce any valid documents in respect of possessing and selling of country spirit in his house as well as he confessed his guilt. Accordingly I seized and labeled 20 bottles seized country spirit styled as "DIL KHUSH" 600 ml in each bottle under proper seizure list in presence of witnesses duly signed by them. Out of seized bottles country spirit 01(One) bottle "DIL KHUSH" is kept as sample. I also arrested the accd. Abhay Kumbhakar (48 yrs) S/O - Lt. Haripada Kumbhakar of Vill- Ichhar, PS-Santaldih, Dist- Purulia.

However the accd. Abhay Kumbhakar committed offence U/S 46A(c) B.E Act, 1909 for possessing and selling of country spirit in his house without any valid documents.

Therefore, I pray before you that a case may be started against accd. Abhay Kumbhakar (48 yrs) S/O - Lt. Haripada Kumbhakar of Vill- Ichhar, PS-Santaldih, Dist- Purulia under proper section of law.
