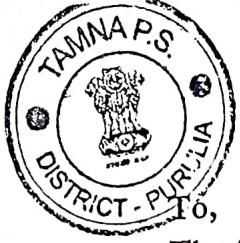

Respected Sir,

I, Gnan Sankar Pati S/O- Ramani Ranjan Pati of Vill+P.O- Chaka, PS- Khatra, Dist- Bankura, at present posted under Tamna PS, Dist- Purulia as ASI of Police producing herewith one arrested accused person namely Manaranjan Paitandi (50 yrs) S/O- Late Lakhikanta Paitandi of Vill- Palma, P.S- Kenda, Dist- Purulia with seized articles i.e. 1) One white colour plastic jerican containing approx 09 Ltrs. of ID Liquor, 2) 05 pcs plastic glasses, 3) One Plastic Bottle containing 1 Ltr. ID liquor as sample which was collected from seized articles SI No-01 which were seized under proper seizure list.

I beg to submit that today (01.01.2023) during my PS mobile duty acting of a secret source information that one person selling I.D Liquor in an open land near Kansai river bed, back side of Krishna Mandir under Tamna PS, myself along with i) C/67 Palash Patra & ii) C/1139 Jiban Senapati both of Tamna PS came to the spot at about 18: 35 hrs and found that one person selling I.D Liquor to the others. Seeing the Police party, all customers fled way but we managed to apprehended the accused person namely Manaranjan Paitandi (50 yrs) S/O- Late Lakhikanta Paitandi of Vill- Palma, P.S- Kenda, Dist- Purulia. On being asked he failed to produce any valid licence /documents in respect of storing and selling of ID liquor. As such I seized 1) One white colour plastic jerican containing approx 09 Ltrs. ID Liquor, 2) 05 pcs plastic glasses, 3) One Plastic Bottle containing 1 Ltr. ID liquor as sample collected from seized articles from SI No-01 which were seized under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in presence of witnesses. I also arranged to inform his family member about his arrest by police.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Manaranjan Paitandi (50 yrs) S/O- Late Lakhikanta Paitandi of Vill- Palma, P.S- Kenda, Dist- Purulia as per proper section of law.
