Respected Sir,

I, Badal Paramanik S/O- Lt. Nirmal Paramanik of Vill+P.O- Biltora, PS- Purulia (M), Dist- Purulia, at present posted under Tamna PS, Dist- Purulia as SI of Police producing herewith one arrested accused person namely Paltu Mandal (35 yrs) S/O- Dharani Mandal of Vill- Lohat, P.S-Kashipur, Dist- Purulia with seized articles i.e. 1) 120 bottles Dilkhush each bottle containing 600 ml. total 72 liter, 2) One Bottle Dilkhus containing 600 ml. as sample collected from seized articles from SI No-01 which were seized under proper seizure list.

I beg to submit that today (19.01.2023) during my PS mobile duty acting of a secret source information that one person carring Liquor (Dilkhus) with his Motor Cycle bearing Registration No. WB56Q/1676 and going towards Chakaltore side on Purulia-Manbazar road under Tamna PS. Accordingly myself along with force left to work out the said source information. Then, we intercepted the aforesaid Motor Cycle near Durku more under Tamna PS at about 14:15 hrs and found that the above noted Motor Cycle was loaded with Liquor (Dilkhus). But seeing the Police party, driver of the said Motor Cycle try to fled away leaving his Motor Cycle but we managed to apprehend him. So, there is every ground to reason to belief that the driver of above noted Motor Cycle selling in liquor (Dilkhus) to others. We waited for reasonable time but none came forward and produce any proper challan or any valid documents related to the said loaded liquor (Dilkhus). So, I seized 1) 120 bottles Dilkhush each bottle containing 600 ml. total 72 liter, 2) One Bottle Dilkhus containing 600 ml. as sample collected from seized articles from Sl No-01 which were seized under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in presence of witnesses. I also arranged to inform his family member about his arrest by police.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Paltu Mandal (35 yrs) S/O- Dharani Mandal of Vill- Lohat, P.S- Kashipur, Dist- Purulia as per proper section of law.
