Sir,

In producing here with the arrested accused persons namely Pappu Hela @ Ajay Prasad (45 Yrs) S/O Lt. Pritam Hela of 64 Colony, Rly Qtr No-268, Unit-D, PS-Adra, Dist- Purulia, A/P-D 64/26 A-6 Madhopur Sagra Chhitupur Mahmoorganj Varanasi, Uttar Pradesh-221010, as disclosed by the arrested accused person along with seized articles under proper seizure list (enclosed here with) i.e. (i) Exhibit Mark-'A'-One white colored nylon Plastic bag (ii) Exhibit Mark-'B'- One transparent colored Plastic bottle along with blue colored cap containing light red colored codeine mixture of 1100 Grm (Including Bottle) (iii) Exhibit mark - 'B1' One small plastic bottle contaminating 100 Grm. codeine mixture taken from Exhibit-"B" as test sample (iv) Exhibit mark "B2" One small plastic bottle containing 100 Grm. of codeine as security sample taken from Exhibit Mark "B". (V) Exhibit Mark-'C'- One transparent colored plastic bottle along with blue colored Cap containing light red colored codeine mixture of 1100 Gm (Including Bottle) (vi) Exhibit mark - 'C1' One small plastic bottle containing 100 Grm. of codeine as test sample taken from Exhibit Mark "C". (vii) Exhibit mark "C2" One small plastic bottle containing 100 Grm. of codeine as security sample taken from Exhibit Mark "C". All Exhibits are in properly sealed and labeled condition under proper seizure list.

I, SI Mekdam Sabab of Adra PS do here by lodged this complaint as suo-motu to the effect that today (23/02/2023) at 21:05 hrs received a secret information from my source that 01(one) person would be coming from Gopinathpur side and may proceed towards Adra side through Adra - Gopinathpur Pitch road with some contraband goods suspected to be narcotic substance in order to sell the same. On received such information I immediately diarized the fact in GD vide Adra PS GDE No 927 dated- 23.02.2023 and informed the matter to IC Adra PS who please directed me to proceed to work out the information. As such as per his direction I SI Mekdam Sabab along with (i) C/2687 Ramanuj Mahanty (ii) JC/1481 Shibu Gope all are of Adra P.S. left for Gopinathpur more i.e. Adra Gopinathpur Pithch Road, after preparing inventory list, by Govt. Vehicle attached to Adra PS equipped with govt. supplied arms and ammunition, weighing machine, investigation kit box, white paper, gala, white cloth, carbon paper, stamp pad, seal of Adra PS, envelope etc. vide Adra PS CC No. 574/23 Dt. 23.02.2023 & Adra PS GDE No-927 dt. 23.02.2023

At about 21:20 hrs reached on Adra Gopinathpur pitch road at near Gopinathpur Eid-Gah, Vill-Gopinathpur, PS- Adra, Dist- Purulia. After reaching, the said Govt. vehicle was kept in reasonable distance conducted ambushed and found 01 (one) person approaching towards Adra side by walking. While he reached closer to police party we surrounded him and focused our torch light and detained him. On asked he disclosed his identity as Pappu Hela @ Ajay Prasad (45 Yrs) S/O Lt. Pritam Hela of 64 Colony, Rly Qtr No-268, Unit-D, PS-Adra, Dist- Purulia, A/P-D 64/26 A-6 Madhopur Sagra Chhitupur Mahmoorganj Varanasi, Uttar Pradesh-221010. We informed him that we have specific information that he has illegal narcotic substance and he admitted that he procured and carrying codeine mixture which is use as contraband narcotic substance without any valid papers and others.

In the meantime one Prakash Moni S/o Satyajit Moni and 2) Rahul Karmakar, S/o- Suresh Karmakar both of Vill- Baghdadabar, PS- Adra, Dist- Purulia who were returning to their home via Adra Gopinathpur pitch road on bike and reached at the said place, I requested them to wait for some while as disinterested witnesses, as because we will be ready to search the above noted one detained person in presence of them.

I also issued notice as per NDPS Act to the detained person in order to conduct his search by an Executive Magistrate or by any Gazetted Police Officer. He informed in writing that he has no objection if the search conducted either by any Gazatted Police Officer or by any Executive Magistrate. Accordingly I told duty officer via phone call to inform IC Adra PS- Insp. Partha Pratim Roy regarding the whole things.

At about 21:45 hrs Insp Partha Pratim Roy, IC Adra PS reached there and I narrated him about the development. He disclosed his identity before the detained person and asked me to issue notice to the detained persons, offering them to search the available police personnel present there as well as the public witness present there, but he showed no interest and refused to conduct any search of the police personal and public witness in writing.

As per direction of IC Adra PS, I conducted search of Pappu Hela @ Ajay Prasad (45 Yrs) S/O Lt. Pritam Hela of 64 Colony, Rly Qtr No-268, Unit-D, PS-Adra, Dist- Purulia, A/P-D 64/26 A-6 Madhopur Sgra Chhitupur Mahmoorganj Varanasi, Uttar Pradesh-221010 in between 21:45 hrs to 22:15 hrs.

During search I recovered one white colour nylon bag in which found two transparent colour plastic Bottle along with blue colored cap containing light red colored liquid. On interrogation he admitted that it is the codeine mixture and he is habituated in dealing of such clandestine illegal business of Codeine for commercial purpose for his wrongful gain, knowing the same is a punishable offence. On demand he failed to produce any documents or justify regarding the storage of huge quantity of contraband codeine mixture. According to the direction of IC Adra P.S I weight the 02 Bottles and it resulted total in 2200 grams including Bottles in weighting machine. On reasonable belief, an offence has been committed in respect of recovered liquid substance believe to be codeine mixture from which 100 gm each were taken in 04 (Four) plastic bottles as test samples and security samples from two mother samples. The said articles were seized U/S 43 of NDPS Act 1985 under proper seizure list duly signed by the witnesses as well as the accused persons. I also supplied a copy of seizure list to the accused persons. I arrested the detained person maintaining all formalities. The seized bottles were properly labeled and sealed.

In between 22:25 hrs to 22:35 hrs I prepared another inventory list containing weighting machine, investigation tool kit, some white paper, used gala, rest white cloth, used carbon paper, stamp pad, seal, burnt candle, two empty small bottles, the two bottles i.e. mother samples consists of 900 gram each and other four bottles contains 100 gml each of seized codeine mixture and two small bottles in presence of witnesses and accused persons. The entire process was supervised and directed by IC Adra PS, Sri Partha Pratim Roy.

On 23/02/23 after returning to the PS seized Alamats and samples were deposited to the Malkhana dealing Officer and kept at PS Malkhana.

At PS the accused person further searched by Police personnel and put him into the PS lock up after observing all Hazat rules and informed on duty table Officer and caution the sentry duty.

That, I the complainant drafted and prepared the complaint by typing on going through the records of the Case. The relative of the arrested accused person is being informed.

The accused persons are liable for prosecution U/S- 21(c) /29 of NDPS Act. 1985 as amended up to date.

Under the above fact and circumstances I like to lodge an FIR against Pappu Hela @ Ajay Prasad (45 Yrs) S/O Lt. Pritam Hela of 64 Colony, Rly Qtr No-268, Unit-D, PS-Adra, Dist- Purulia, A/P-D 64/26 A-6 Madhopur Sgra Chhitupur Mahmoorganj Varanasi, Uttar Pradesh-221010, U/S- 21 (c) /29 of NDPS Act 1985 as amended up to date and arrange for its investigation.
