In producing herewith 06 (Six) accused persons namely 1) Ramu Bauri (28 Yrs), S/O-Dhomu Bauri 2) Mukesh Yadav (26 yrs), S/O-Ram Singh Yadav 3) Rahul Bauri (19 Yrs) S/O Santosh Kumar Bauri 4) Dilip Kumar Turi (20 Yrs) S/O Rohit Kumar Turi all are D type Khatal Rangamati Purvi, PS-Chandrapura, Dist-Bokaro 5) Santu Kumar Murmu (24 Yrs) S/O Chotu Majhi of Rangamati TSC Basti, PS-Chandrapura, Dist-Bokaro 6) Chotu Kumar Pasi (19Yrs) S/O Bhoja Pasi of Basdepur Ekra Para, PS-Loyabod, Dist-Dhanbad along with seized articles such as 1. One Iron Bhojali having wooden butt having length of approx 12.00 inch 2. One Iron rod which is one side arrow headed having length of approx 3½.ft. 3. One Bamboo Stick having length of approx 4 feet as per seizure list. 4. One Screw Driver length approx 1.5 ft. 5. One Silver colour Maruti Suzuki EECO Star four wheeler having Reg. No-JH09AC/6702. 6. One Black colour Pilsner No. 160 Motor Cycle having Reg. No-JH10CN/4122

I SI Simanta Tantubai do hereby submit that on 22.02.2023 at 20:45 hrs while performing evening mobile duty vide C.C. No-564/23, Dated- 22.02.2023, received a source information that 08-10 persons were assembled beside Adra Kashipur pitch Road near Shantidham Bridge with a view to commit Dacoity. I informed the matter to I/C Adra PS and as per order of I/C Adra PS, I along with forces namely 1) C/ 1272 Bikash Ch. Patra 2) C/140 Subrata Banerjee 3) C/1091 Suroj Mahato all of Adra PS left for Shantidham Bridge to work out the said information.

I along with force reached at Shantidham Bridge at about 21:05 hrs by keeping the police vehicle at a distance of 300 meters (approx) away. Then we approached to the Shantidham Bridge area. We heard suspicious human voices at a distance from 25-30 meters, talking amongst them. I also found 08-10 persons were assembled there along with one Silver colour four wheeler bearing reg. No-JH09AC/6702 and a Black colour two wheeler bearing reg. No-JH10CN/4122 and after having heard and seen this, I along with forces confronted suspicious character as police party and they tried to flee away from the spot, but we able to apprehend above noted 06 persons. On being asked they disclosed their identity as noted above. Rest 03-04 persons fled away from the spot due to the darkness as well as the topography of the locality. Then I offered the detained persons to search me and my Police party before searching their body, but they refused. After that we searched them. During search I found 1. One Iron Bhojali having wooden butt having length of approx 12.00 inch recovered from the possession of Ramu Bauri. 2. One Iron rod which is one side arrow headed having length of approx 3½.ft recovered from the possession of Mukesh Yadav, 3. One Bamboo Stick having length of approx 4 feet recovered from the possession of Rahul Bauri. 4. One Screw Driver length approx 1.5 ft recovered from the possession of Dilip Kumar Turi. On interrogation the accused persons disclosed their names and address as noted above and confessed that they have come there by above noted two vehicle and they were assembled there for committing Dacoity at Adra Market area during this night. So, I seized the above noted articles along with above noted vehicles and labeled duly signed by the police witnesses as no local witnesses available there then arrested them informing the ground of arrest, observing all arresting guidelines. As it was evident during our raid the accused persons assembled at a solitary place and were preparing amongst themselves with weapons found in their possessions for committing Dacoity at Adra Market area, actually committed an offence punishable U/S- 399/402 IPC. In view of this I arrested the above noted 06 (Six) accused persons and seized the weapons from their possession by preparing proper seizure list on the spot duly signed by the accused persons as well as police party and brought them to P.S. The whole process was done i.e. search, seizure and arrest in between 21.25 hrs to 22.15 hrs.

Hence I pray a specific case may kindly be started against 1) Ramu Bauri (28 Yrs), S/O-Dhomu Bauri 2) Mukesh Yadav (26 yrs), S/O-Ram Singh Yadav 3) Rahul Bauri (19 Yrs) S/O Santosh Kumar Bauri 4) Dilip Kumar Turi (20 Yrs) S/O Rohit Kumar Turi all are D type Khatal Rangamati Purvi, PS-Chandrapura, Dist-Bokaro 5) Santu Kumar Murmu (24 Yrs) S/O Chotu Majhi of Rangamati TSC Basti, PS-Chandrapura, Dist-Bokaro 6) Chotu Kumar Pasi (19Yrs) S/O Bhoja Pasi of Basdepur Ekra Para, PS-Loyabod, Dist-Dhanbad & other 03/04 unknown miscreants under proper section of law and arrange its investigation.
