Sir,

In producing here with seized article i.e. 01 (one) Mini truck (1109) having Registration No- WB55/5061 loaded with approx 02 Ton iron cutting angel, to the effect that I, ASI Janardan Kumar along with C/-238 Dipak Bagti & C/-222 Pravash Ch. Mandal both of Arsha P.S. Dist-Purulia vide CC No-350/23 Dated-07/02/2023 were engaged in Day mobile duty at Kantadih side area on Purulia-Tata Pitch Road (NH-32) under Arsha PS Dist-Purulia. During mobile duty we found that above noted mini truck was standing at near over bridge (new construction), near Kantadih rail gate, under Arsha P.S When we reached there and found that the said Mini truck loaded huge quantity of iron cutting angel. We try to collect the name of driver & owner of the said Mini truck but nobody were found there. So it has reason to believe that the driver & owner of the above noted Mini truck of the said iron cutting angel either by theft or by any other fraudulent means from anywhere and transporting the same to earn money for wrongful gains. It is clear that the above noted Mini truck (1109) having Registration No- WB55/5061 transporting iron cutting angel illegally. So I seized the same under proper seizure list in between 14.15 hrs to 14.55 hrs, Dtd. 07/02/2023 & label duly signed by witnesses and bought the same at Arsha P.S.

I therefore pray before you, kindly lodge an FIR against the driver & owner of the Mini truck (1109) having Registration No- WB55/5061 as per law and arrange for its investigation.
